ORDER

Sri T. GOPI, R/o Khammam District filed 2nd appeal dated 06-10-2019 which was received by this Commission on 03-02-2020 for not getting the information sought by him from the PIO / O/o The Narsampet Municipality, Narsampet Mandal, Warangal Rural District and 1st Appellate Authority / O/o The Narsampet Municipality, Narsampet Mandal, Warangal Rural District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **09-08-2019** under Sec.6(1) of the RTI Act, 2005, before the PIO seeking the following information:

- 1) TFS, SFC, జనరల్ ఫండ్ మరియు వివిధ ఫండ్స్ కి సంబంధించిన లెక్కలు, జమల కాష్ బుక్, తీర్మానం బుక్స్ నకళ్లు తెలపగలరు.
- 2) ఇంటి పన్ను, పంపు బిల్లులు, కమర్షియల్ షాపులకు సంబంధించిన రోజువారీ ఎంత పన్నులు వసూలు చేస్తున్నారు. ఎంత జనరల్ ఫండ్స్ లో జమ చేస్తున్నారు. వాటికి సంబంధించిన చలనా నకళ్లు లభిస్తే కట్టిన
- 3) వీధిలైట్లు బ్లీచింగ్ పౌడర్, మున్సిపాలిటీ అవసరాలకు కొనుగోలు చేసిన బిల్లు నా కలే మాకు తెలపగలరు.
- 4) ఇంటి నెంబర్ మరియు వెంచర్లు బిల్డింగులు నిర్మాణం కోసం ఎంతమంది అనుమతి కోరారు కోరినవారు బ్యాంకు చల్లార్చిన క! లు రిజిస్ట్రేషన్ మరియు అనుమతి పత్రం శ్రాకర్షిత తెలపగలరు
- 5) ఇంటి నెంబర్ మార్పిడి డిమాండ్ రిజిస్టర్ నకళ్లు మాకు తెలపగలరు.
- 6) మున్సిపాలిటీ CC రోడ్లు, కల్వర్టులు, బిల్డింగ్, నిర్వహిస్తున్న రోడ్ నెంబర్ లు హద్దులు MD రికార్డు నకళ్లు CD ఇవ్వగలరని కోరుచున్నాము.

The Public Information Officer has not furnished the sought information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1st appeal dated **30-09-2019** before the 1st Appellate Authority requesting him to furnish the information sought.

As per the records enclosed it is noticed that the 1st Appellate Authority had failed to hear the case and pass appropriate orders on the 1st appeal filed before him.

As the appellant did not get information from the Public Information Officer, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him.

The 2nd Appeal was taken on file and notices were issued to the parties concerned for hearing on **24-05-2022**.

On **24-05-2022** the case is called. The Appellant is absent. The Public Information Officer, O/o the Municipal Commissioner, Narsampet Municipality, Narsampet, Warangal District is absent. The 1st Appellate Authority is absent.

The record goes to show that the 6(1) application was filed on 09-08-2019 and the Public Information Officer has not furnished sought information to the appellant so far.

It is observed that the appellant in his 6(1) application sought voluminous information covering several subjects without disclosing larger public interest involved. He is advised to seek specific information in future, so as to enable the Commission to issue appropriate directions to the Public Information Officer.

The Commission directs the Public Information Officer to furnish available information duly adhering to the provisions of RTI Act 2005 to the appellant within (30) days from the date of receipt of this order and submit compliance to the Commission.

With the above direction, **the Appeal is closed.**

Issue **show cause notice** to Public Information Officer for not furnishing the sought information to the appellant within the stipulated time and for not attending hearing before the Commission. The action on the show cause notice shall be dealt with separately.
