ORDER

Sri K. Narayana Singh, R/o. Hanumakonda District has filed a Complaint dated 09-12-2019 which was received by this Commission on 09-12-2019 for not getting the information sought by him from the PIO / O/o. the Greater Warangal Municipal Corporation, Warangal.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated 08-07-2019 under Sec.6(1) of the RTI Act, 2005, before the PIO seeking following information:

మీ నామ దరఖాస్తుకు ప్రతిస్పందన లేకుండా 19.03.19, 22.04.2019, 20.05.2019, 10.06.2019 మరియు
17.06.2019 తేదీలకు ప్రతిస్పందన లేకుండా సమాచారం అందించాలి. ఇవి ముందే పొందబడినవి.
చర్యలు చేపట్టడానికి మూడు నెలలు కంటే ఎక్కువ కాలం పట్టినట్లయితే ప్రతిస్పందన లేకుండా సమాచారం అందించాలి.
అన్ని వివరాలు పొందాలి. ప్రస్తుతం ఏమిటి చేయబడింది?

The PIO has not furnished the sought information to the complainant.

As the complainant did not receive the sought information from the PIO even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him.

The Complaint was taken on file and notices were issued to both the parties for hearing on 07-09-2021.

On 07-09-2021 the case is called. The Complainant is present. The PIO / O/o. the Greater Warangal Municipal Corporation, Warangal is absent. Sri V.Sunil, Junior Assistant, O/o. the Greater Warangal Municipal Corporation, Warangal is present.

The complainant submitted that he did not receive any information from the PIO so far.

The representative of the PIO submitted that the information was furnished on 06-01-2019.

Heard both the parties and perused the records.

The record goes to show that the 6 (1) application was filed on 08-07-2019 before Greater Warangal Municipal Corporation, Warangal seeking information on (6) points. The letter of PIO dated 06-01-2019 was prior to filing of 6 (1) application. The PIO has not furnished any information to the complainant so far. Thus he misled the Commission stating the information was furnished to the complainant.

The Complainant further submitted that he is retired Government servant owning a house near the Xerox shop. He is living with his wife and are senior citizens. The Xerox machine shop is causing much inconvenience by emitting bad smell of chemicals. That they are suffering a lot. That due to negligence of GWMC, Pollution Board and Industries Department they are presently living at a distance in a rented house. Thus, they are put to untold misery and requested to do Justice in the matter.

The Commission is of the view that the plea of the complainant is very genuine one and needs immediate attention of all Departments concerned to arrange to shift the Xerox printing shop from the residential area.

Hence, the Commission directs the PIO / O/o. the Greater Warangal Municipal Corporation, Warangal to cause discrete enquiry and ensure that the genuine grievance of the Senior Citizen is resolved on humanitarian grounds, either by making necessary precautionary measures in the shop or relocating the shop as per procedure within (30) days from the date of receipt of this order and submit compliance.

With the above direction, the Complaint was adjourned to 26-04-2022.

On 26-04-2022 the case is called. The Complainant is present. The Public Information Officer, O/o the Municipal Commissioner, GWMC, Warangal is absent. The Sanitary Inspector is present on behalf of the Public Information Officer.

This case was earlier heard on 7-9-2021 and adjourned with a direction to the PIO to cause discrete enquiry and ensure that genuine grievance of the Senior Citizen is resolved on humanitarian grounds.

The Complainant submitted that he did not receive the sought information from the Public Information Officer.

The representative of the Public Information Officer filed affidavit of the Public Information Officer submitting that the sought information was furnished to the Complainant on 23-09-2021.

Heard both the parties and perused the records.

The information furnished by the Public Information Officer on 23-9-2021 refers to another application dated 23-11-2019 of the Complainant and does not relate to the matter of the present 6(1) application. The Complainant in his 6(1) application sought information on five points regarding the norms maintained in issue of license to Xerox shop adjoining his house.

The Commission observed that in spite of the directions issued by the Commission earlier no action has been taken by the Public Information Officer to resolve the issue of Complainant nor furnished the sought information.

The Commission took serious view of the lethargic attitude of the Public Information Officer and he is directed to furnish the sought information to the Complainant **within (15) days** from the date of receipt of this order and report compliance to the Commission.

With the above direction, **the Complaint is closed.**
