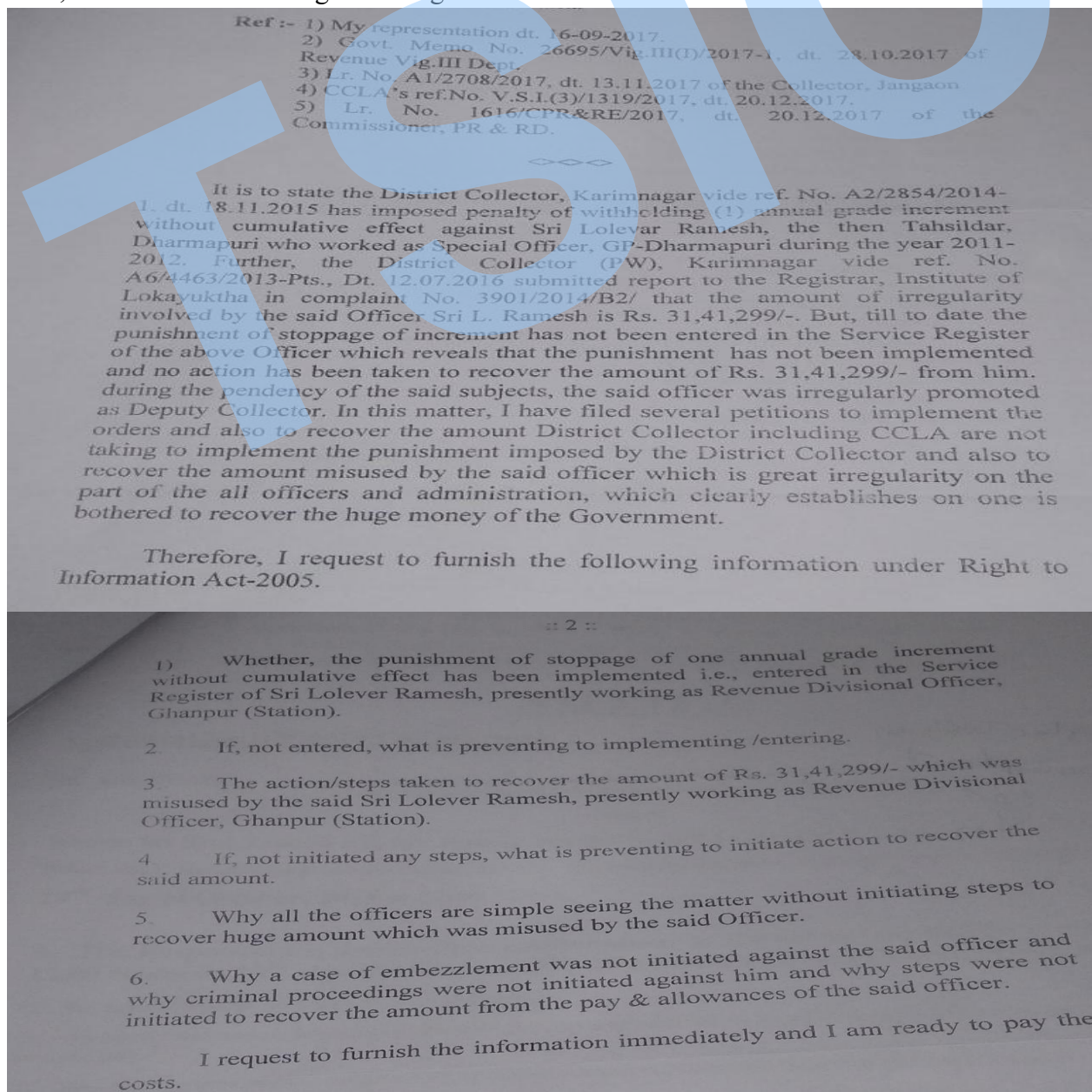

## ORDER

Sri Syed Azmath Ali, R/o. Jagityal District has filed a Complaint dated 01-12-2018 which was received by this Commission on 03-12-2018 for not getting the information sought by him from the PIO / The District Revenue Officer, O/o. the Collector, Karimnagar District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated 07-09-2018 under Sec.6(1) of the RTI Act, 2005, before the PIO seeking following information:



The PIO has not furnished the sought information to the complainant.

As the complainant did not receive the sought information from the PIO even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him.

The Complaint was taken on file and notices were issued to both the parties for hearing on 19-10-2020.

**The case was earlier heard on 19-10-2020** and was adjourned directing the PIO to transfer the 6 (1) application to the PIO / O/o. the Collector, Mancherial District.

**On 23-03-2021 the case was called again** and adjourned with a direction to the PIO to furnish the information sought by the complainant i.e., “whether the entries were made in the Service Register” of Sri L.Ramesh.

**On 12-07-2021 the case is called again.** The Complainant is present. The PIO / O/o. the District Collector, Mancherial is absent and authorized Sri Kashaboina Suresh, AO Administrative Officer, O/o. the Collector, Mancherial District.

The Complainant submitted that he has not received the sought information so far.

The representative of the PIO submitted that the sought information could not be furnished to the complainant as the Service Book was available with L.Ramesh, the then RDO, Mancherial. Who went on long leave and did not resume duty. He further submitted that the RDO, Sri L.Ramesh is posted as RDO, Thorrur Division, Mahabubabad District and he is working in the said place now.

Heard both the parties and observed that the Complainant is made to visit various offices for seeking simple information since 2018 stating that the Service Book of the individual is not with them to verify whether the punishment awarded by the then Collector, Karimnagar on L.Ramesh was entered in the Service Register of the individual.

In view of the above submission of PIO / O/o. the District Collector, Mancherial District, the PIO / RDO, Thorrur Division, Mahabubabad District is directed to furnish the sought information to the Complainant within (15) days from the date of receipt of this order and submit compliance to the Commission.

With the above direction, the complaint was adjourned to 26-04-2022.

**On 26-04-2022 the case is called.** The Complainant is present. The Public Information Officer / Revenue Divisional Officer, Thorrur Division, Mahabubabad District is absent. The Senior Assistant is present on behalf of the Public Information Officer.

This case was earlier heard on 12-07-2021 and adjourned with a direction to the Public Information Officer / RDO, Thorrur Division to furnish the sought information to the Complainant within (15) days from the date of receipt of this order and report compliance to the Commission.

The Complainant submitted that he did not receive the sought information from the Public Information Officer.

The representative of the Public Information Officer filed affidavit of the Public Information Officer submitting that the sought information was furnished to the Complainant on 13-08-2021 by speed post vide letter No.D/773/2021. The representative of the Public Information Officer also brought a copy of the service book of Sri L.Ramesh, RDO, Ghanpur duly entering the punishment awarded by the then District Collector, Karimnagar. A copy of the same was furnished to the Complainant in presence of the Information Commission.

Since information is furnished, **the Complaint is closed.**
