ORDER

Sri K.RAJALU, R/o Warangal Urban District filed 2nd appeal dated 06-02-2020 which was received by this Commission on 08-02-2020 for not getting the information sought by him from the PIO / O/o The Executive Engineer, Engineering Department, Greater Warangal Municipal Corporation, Warangal District and 1st Appellate Authority / O/o The Assistant Municipal Commissioner, Greater Warangal Municipal Corporation, Warangal District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **04-09-2019** under Sec.6(1) of the RTI Act, 2005, before the PIO seeking the following information:

2. పైన పేర్కొన్న డ్రాయింగుల నిర్మాణం పైన వివరించిన ప్రాక్టుల ఎదోని ఫిర్యాదు ల చేసిన యొక్క పునరుద్ధారణ యొక్క సర్టిఫైడ్ copy ని. attestation చేసి ప్రస్తావించిన తమ అనుసరించబడుచున్న.

నోట్: పైన పేర్కొన్న సర్టిఫైడ్ కోపీలను పొందుట కు నిర్దేశించిన సమయము ఆలోచన చేసి పునరుద్ధారణ యొక్క ఫలతాలను పొందగలవని తమ అనుసరించే చేసు మరియు తమ సరకు యొక్క సర్టిఫైడ్ కోపీలను attestation చేసి సకాలంలో ఇవ్వగలవని వా యొక్క ప్రార్థన.

The Public Information Officer has not furnished the sought information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1st appeal dated **26-10-2019** before the 1st Appellate Authority requesting him to furnish the information sought.

As per the records enclosed it is noticed that the 1st Appellate Authority had failed to hear the case and pass appropriate orders on the 1st appeal filed before him.

As the appellant did not get information from the Public Information Officer, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him.

The 2nd Appeal was taken on file and notices were issued to the parties concerned for hearing on **18-04-2022**.

On 18-04-2022 the case is called. The Appellant is absent. The Public Information Officer / Deputy Executive Engineer, GWMC, Warangal is present. The 1st Appellate Authority is absent.

The Public Information Officer submitted that the sought information is ready and is being furnished to the appellant.

The appellant did not choose to attend the hearing nor filed affidavit offering his version.

The record goes to show that the 6(1) application was filed on 04-09-2019 and the information is being furnished by the Public Information Officer with a delay of two years.

The Commission directs the Public Information Officer to furnish sought information to the appellant **within (15) days** by RPAD from the date of receipt of this order and submit compliance to the Commission.

With the above direction, **the Appeal is closed.**

Issue **show cause notice** to Public Information Officer for not furnishing the sought information to the appellant within the stipulated time. The action on the show cause notice shall be dealt with separately.
