

ORDER

Sri R.JANARDHAN, R/o Hyderabad filed 2nd appeal dated 19-07-2017 which was received by this Commission on 03-08-2017 for not getting the information sought by him from the PIO / Assistant Director of Marketing, O/o The Director of Agriculture and Marketing, Ground Floor, D-block Fathe Midan, Near Nizam College, Basheer Bagh, Hyderabad, Telangana 500001 and 1st Appellate Authority / Additional Director of Marketing, O/o The Commissioner & Director of Agriculture and Marketing, Ground Floor, D-block Fathe Midan, Near Nizam College, Basheer Bagh, Hyderabad, Telangana 500001.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 11-05-2017 under Sec.6(1) of the RTI Act, 2005, before the PIO seeking the following information:

The Public Information Officer through Memo. No.1200/Mktg.II(2)/2017 dated 14-06-2017 furnished the sought information to the appellant.

Stating that the information furnished by the Public Information Officer is incomplete / incorrect, the appellant filed 1st appeal dated 23-06-2017 before the 1st Appellate Authority requesting him to furnish the information sought.

As per the records enclosed it is noticed that the 1st Appellate Authority had failed to hear the case and pass appropriate orders on the 1st appeal filed before him.

As the appellant did not get information from the Public Information Officer, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him.

The 2nd Appeal was taken on file and notices were issued to the parties concerned for hearing on **24-11-2020**.

On 24-11-2020 the case was called. The appellant is present. The Public Information Officer, O/o the Director of Agriculture Marketing sent letter submitting that the notices have been received from the Commission on 24-11-2020. She further submitted that she has been posted as Presiding Officer in GHMC Elections and as such unable to attend the hearings on 24-11-2020. Hence she requested to postpone the case. The appellant agreed for the same.

In view of the submission of the Public Information Officer, the case was adjourned to **11-04-2022**.

On 11-04-2022 the case is called. The Appellant is present. The Public Information Officer / Assistant Director, O/o the Director of Agriculture Marketing, Hyderabad is present. The 1st Appellate Authority is absent.

The Appellant submitted that he did not receive the sought information from the Public Information Officer.

The Public Information Officer submitted that factual information was furnished to the appellant on 06-04-2017 and 21-10-2017.

The Commission directs the Public Information Officer to furnish a copy of information once again to the appellant **within (15) days** from the date of receipt of this order and submit compliance to the Commission.

With the above direction, **the Appeal is closed.**
