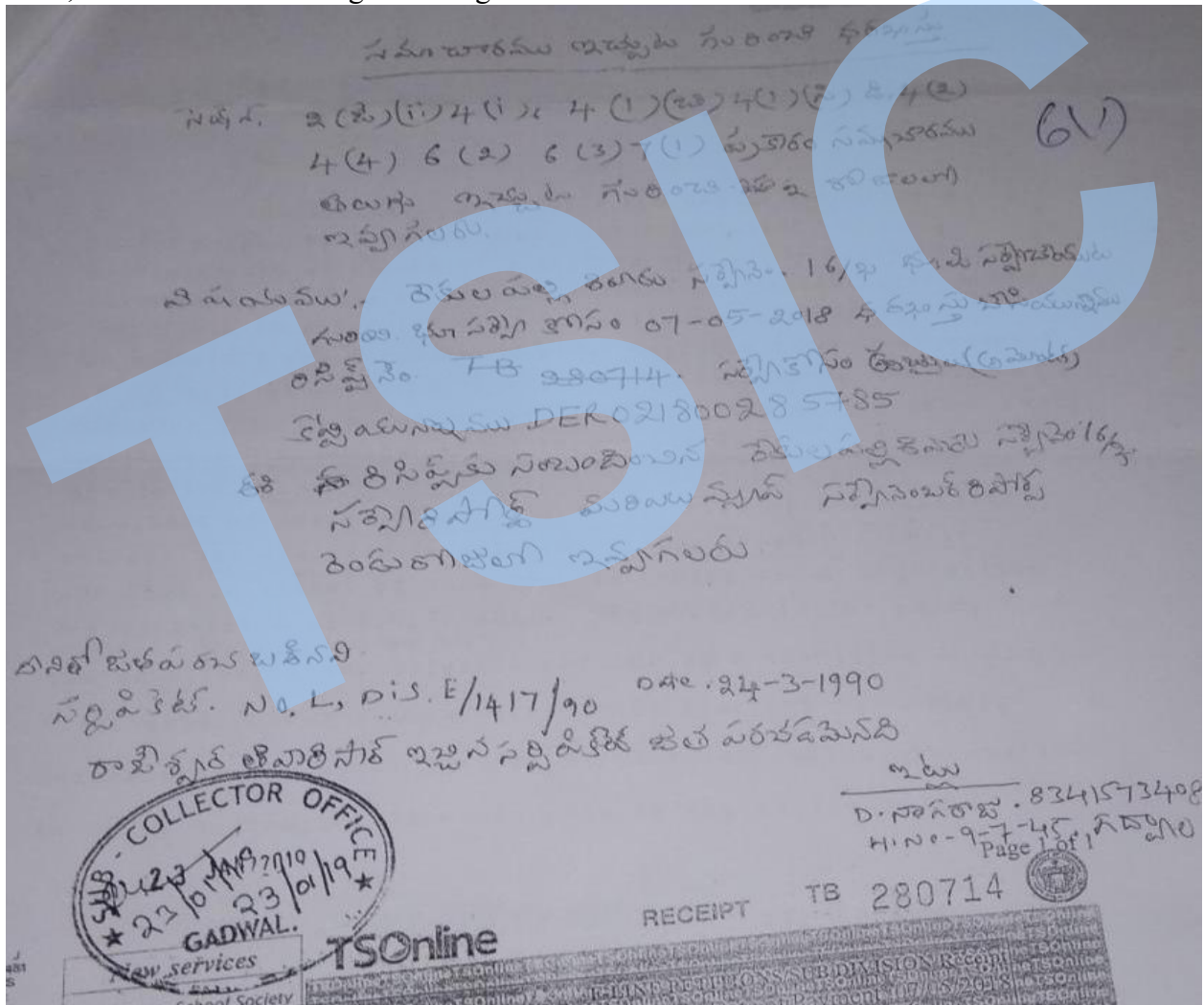

ORDER

Sri D.Nagaraju, R/o. Gadwal District has filed a Complaint dated 17-02-2019 which was received by this Commission on 21-02-2019 for not getting the information sought by him from the PIO / O/o. the Tahsildar, Gadwal Mandal, Jogulamba Gadwal District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated 23-01-2019 under Sec.6(1) of the RTI Act, 2005, before the PIO seeking following information:



The PIO has not furnished the sought information to the complainant.

As the complainant did not receive the sought information from the PIO even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him.

The Complaint was taken on file and the Complaint was posted for hearing on **21-07-2020**.

On overview spread of COVID-19, the case was heard over phone on 21-07-2020 and adjourned with a direction to the PIO to furnish correct and proper information to the Complainant within (15) days and submit compliance report.

On 12-07-2021 the case is called again. The Complainant is absent. The PIO / O/o. the Tahsildar, Gadwal Mandal, Jogulamba Gadwal District is absent.

The record goes to show that the 6 (1) application was filed on 23-01-2019 and no information is furnished by the PIO to the Complainant despite orders of the Commission.

The Public Information Officer is once again directed to furnish the sought information to the Complainant within one week and submit compliance to the Commission.

Issue Show Cause Notice to the Public Information Officer for not furnishing information and for not attending hearing before the Commission.

With the above direction, the Complaint was **adjourned to 26-04-2022.**

On 26-04-2022 the case is called. The Appellant is absent. The Public Information Officer / Naib Tahsildar, Gadwal Mandal, Jogulamba Gadwal District is absent. The Senior Assistant is present on behalf of the Public Information Officer. The 1st Appellate Authority is absent.

The case was earlier heard and adjourned on **12-07-2021** with a direction to Public Information Officer to furnish sought information to the appellant within (15) days from the date of receipt of this order and report compliance to the Commission.

The representative of the Public Information Officer filed affidavit of the Public Information Officer submitting that as per directions of the Information Commission the information was furnished to the appellant on 22-12-2021 by RPAD.

Since information is furnished, **the Appeal is closed.**
