ORDER

Sri M. PADMANABHA REDDY, R/o Hyderabad District filed 2nd appeal dated 26-02-2020 which was received by this Commission on 26-02-2020 for not getting the information sought by him from the PIO / O/o The Chairman & Managing Director, TSSPDCL, 6-1-50, Mint Compound, Hyderabad and 1st Appellate Authority / O/o The Chairman & Managing Director, TSSPDCL, 6-1-50, Mint Compound, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 17-05-2019 under Sec.6(1) of the RTI Act, 2005, before the PIO seeking the following information:

I am here with enclosing the news paper clipping of Andhra Jyothi (Telugu daily) dated 10-5-2019 which is self explanatory. In this regard kindly provide the following information.

1. Copies of correspondence (letters) sent by TS DISCOM to Government of Telangana for release of funds.
2. Pay structure of staff (salaries) working in TS DISCOM
 - i) Chief Engineer
 - ii) S.E.
 - iii) D.E.
 - iv) -----
 - v) -----
3. Copy of notice issued by N.T.P.C. for payment of arrears
4. Arrears amount due from government departments to TS DISCOM
5. Arrears due from Panchayat institutions

6. Details of Power purchased during 2018-19 and amount paid or to be paid

The Public Information Officer through Letter No. SPIO&JS/DS(Per.II)/AS(L&R)/JPO(L&R)F.No14/2020 dated 13-02-2020 transferred the application U/s 6(3) to the Public Information Officer, O/o The Chairman & Managing Director, TSSPDCL, 6-1-50, Mint Compound, Hyderabad for furnishing the sought information.

The Public Information Officer has not furnished the sought information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1st appeal dated 19-07-2019 before the 1st Appellate Authority requesting him to furnish the information sought.

As per the records enclosed it is noticed that the 1st Appellate Authority had failed to hear the case and pass appropriate orders on the 1st appeal filed before him.

As the appellant did not get information from the Public Information Officer, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him.

The 2nd Appeal was taken on file and notices were issued to the parties concerned for hearing **on 10-05-2022**.

On 10-05-2022 the case is called. The Appellant is absent. The Public Information Officer, O/o the Chairman & Managing Director, TSSPDCL, Mint Compound, Hyderabad is present. The 1st Appellate Authority is present.

The Public Information Officer submitted that the sought information was furnished to the appellant on 30-8-2019 vide letter No.ID No.112/2019, D.No.278/2019, letter No.284/2019 dated 31-08-2019 and letter no.83/2020 dated 3-3-2020 by speed post.

The appellant did not choose to attend the hearing nor filed affidavit offering his version.

Since available factual information is furnished, **the Appeal is closed.**
