## **ORDER**

Sri SRINIVAS PONNA, R/o Jangaon District filed 2<sup>nd</sup> appeal dated 26-02-2020 which was received by this Commission on 28-02-2020 for not getting the information sought by him from the PIO / O/o The Public Relation Officer, Corporate Office, TSNPDCL, Warangal, Warangal District and 1<sup>st</sup> Appellate Authority / O/o The Chief General Manager(HRD),TSNPDCL, Warangal District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 05-12-2019 under Sec.6(1) of the RTI Act, 2005, before the PIO seeking the following information:

- 1) TSNPDCL లో విద్యుత్ సౌకర్యం కలిగి ఉన్న వాటిని గురించి తెలియజేసే అంశం 5.12.19 వరకు వాటిని కరణాలలో డిస్కం/ట్రాన్సిమిటర్ అయిన ఉద్దేశ్యాల/కాంట్రాక్టు ఉద్దేశ్యాల వివరాలు క్రింద పేర్కొనబడిన విధంగా ఇవ్వగలరు. ఉద్దేశ్యాల, హాదా, డిస్కం/ట్రాన్సిమిటర్ అయిన తేది, కరణం
- 2) డిస్కం/ట్రాన్సిమిటర్ అయ్యే కొద్దు తీర్పు ద్వారా అడ్మినిస్ట్రేషన్ అయితే ఉద్దేశ్యం పొందవలసి మరియు పొందని వారి వివరాలు ఇవ్వగలరు
- 3) డిస్కం/ట్రాన్సిమిటర్ అయ్యే కొద్దు తీర్పు ద్వారా కరణం అయితే ఉద్దేశ్యం పొందవలసి వివరాలు ఇవ్వగలరు.

The Public Information Officer through letter No. Public Information Officer&PRO/NPDCL/Wgl/App1.No.181/19/D.No.756/19 dated 20-12-2019 and ref No.833/19 dated 03-02-2020 furnished the sought information to the appellant.

Stating that the information furnished by the Public Information Officer is incomplete / incorrect, the appellant filed 1<sup>st</sup> appeal dated 22-01-2020 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought.

As per the records enclosed it is noticed that the 1<sup>st</sup> Appellate Authority had failed to hear the case and pass appropriate orders on the 1<sup>st</sup> appeal filed before him.

As the appellant did not get information from the Public Information Officer, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to arrange to furnish the information sought by him.

The 2nd Appeal was taken on file and notices were issued to the parties concerned for hearing on **10-05-2022**.

**On 10-05-2022** the case is called. The Appellant is absent. The Public Information Officer / PRO, O/o the CMD, Corporate Office, TSNPDCL, Warangal is present. The 1st Appellate Authority is absent.

The Public Information Officer submitted that the factual information was furnished to the appellant on 20-12-2019 and on 3-2-2020 informed the appellant that the sought information is exempted u/s 8(1)(j) of RTI Act 2005 as he is seeking the information of disciplinary proceedings initiated against all employees.

Since factual information is furnished, **the Appeal is closed.**
