ORDER

Sri K. SHIVANAGA KUMAR, R/o Hyderabad District has filed a Complaint dated 19-02-2020 which was received by this Commission on 19-02-2020 for not getting the information sought by him from the PIO / O/o The Joint Secretary, Corporate Office, TSTRANSCO, Vidyut Soudha, Hyderabad.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated 30-11-2019 under Sec.6(1) of the RTI Act, 2005, before the PIO seeking following information:

For one normal contractor had did work with your organization with your company staff giving promise why did they or not standing on that promise.

I specially requested MR.B.S.PRAKESH (V.P) when he is coming WO:- 293A project he will called up me and spoke like dearest friend or Brother. After commissioning his behavior like dam difficult with contractors like not lifting the phone, not giving the reasons for delay of payment, treating like some unknown person is calling, I am not blaming that person, I am informing you only.

Why because I am inform you that before some days I had giving a call and what'sapp message putting like I am financially struggle with Financiers me and my family, and my mother had suffering with CANCER. For my mother cancer treatment I am facing lots of problems please give me a hope or help me sir As soon As possible. But I had seen the message and did not giving reply. When I called him did not lift 3days created mentally deputation.

After days One fine day around 11.50 am or 12.05pm he is attend the call and our conversation is like this.

B:S:PRAKESH sir: - Yes Srinivas tell me.

Me :- good after noon sir. What about my concern.

B.S.Prakesh sir: - Srinivas your Retention money finalizing it will take some time due to the reason of T.S TRANSCO is not finalizing our HARD ROCK amendment and did not giving clarity of Hard Rock payment.

Once they will give clarity about that we will work on your retention and finalize them. If they did not give H.R amendment we will deduct the amount from your Retention and affcourse it will take time taking process you should have to wait, and I am also asking you put a gang in VJAYAWADA OR HYDERABAD Projects you did not helped me, when you are put a gang in these projects your Retention are cleared with our organization like this way his behavior. Until that we don't do anything for your mother Treatment like he is saying.

In that time your company staff and department also took pics from our site at blasting.

For my query is if you are not taking amendment why your organization is continuing the work. If I am telling lies did not solve the matter in talking phones and meeting. Please come site and I will reopen the foundations and prove them.

And now I am feeling like don't heard peoples voice don't believe the persons because they are like made selfish. When they have a work with sub contractor they are like talk HONEY. When work is completed work behaves like cruel and POISSON words are speak.

Now also I am not blaming your company and your people also.

I have no other chance to do the any action about this and I did not come and let explain the problem because if I had to go Bangalore or Ahmadabad I want to spend 10 thousands of bucks. If I have this amount can I spend my mother Treatment?

The PIO through Lr.No. SPIO&JS/DS(Per.II)/AS(L, R&C)/PO(L&R)/C.NO.364/19 dated 06-12-2019 furnished the reply to the complainant that the application rejected U/s 2(f) RTI Act, 2005.

Stating that the information furnished by the Public Information Officer is incomplete / incorrect, the complainant preferred this Complaint before this Commission requesting to arrange to furnish the information sought by him.

The Complaint was taken on file and notices were issued to the parties concerned for hearing on 10-05-2022.

On 10-05-2022 the case is called. The Complainant is present. The Public Information Officer / Superintending Engineer, TS TRANSCO, Vidyuth Soudha, Hyderabad is present.

The Complainant submitted that he did not receive the sought information from the Public Information Officer.

The Public Information Officer submitted that the sought information was rejected u/s 2(f) of RTI Act 2005 on 06-12-2019 as he did not seek any information.

Heard both the parties and perused the records.

The matter raised by the Complainant in his 6(1) application is apparently a grievance which would not attract the provisions of RTI Act 2005.

With the above observation, **the Complaint is closed.**
