## **ORDER**

**Sri I. RAM MOHAN, R/o Mancherial District** filed 2<sup>nd</sup> appeal dated 03-03-2020 which was received by this Commission on 05-03-2020 for not getting the information sought by him from the PIO / Divisional Engineer Electrical, O/o The DE, TSNPDCL, Operation, Sub Division, Bellampally-504251, Mancherial District and 1<sup>st</sup> Appellate Authority / O/o The Superintending Engineer TSNPDCL, Operation Circle, Mancherial District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **23-12-2019** under Sec.6(1) of the RTI Act, 2005, before the PIO seeking the following information:

షేడ్యూల్ మరియు అగ్రెగేట్ యిట్ స్టాంపు అని నాకు తగు సమాచారం ఇవ్వగలదా?

The Public Information Officer through letter No. DEE/OP/ BPL/AE(Tech) /F.No.RTI/ D.No.1685 dated 22-01-2020 requested to the appellant to pay an amount of Rs.769/-towards cost of information, for sanction letters and estimations, while furnishing information for remaining points.

Stating that the information furnished by the Public Information Officer is incomplete / incorrect, the appellant filed 1<sup>st</sup> appeal dated **27-01-2020** before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought.

As per the records enclosed it is noticed that the 1<sup>st</sup> Appellate Authority had failed to hear the case and pass appropriate orders on the 1<sup>st</sup> appeal filed before him.

As the appellant did not get information from the Public Information Officer, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to arrange to furnish the information sought by him.

The 2<sup>nd</sup> Appeal was taken on file and notices were issued to the parties concerned for hearing on **10-05-2022**.

**On 10-05-2022** the case is called. The Appellant is absent. The Public Information Officer / Divisional Engineer, Electrical, Operation, TSNPDCL, Bellampally, Mancherial District is present. The 1<sup>st</sup> Appellate Authority is absent.

The Public Information Officer submitted that the factual information was furnished to the appellant on 22-01-2020 regarding ORC, DTR and subsidy etc., as regards sanctioned letters and estimates the appellant was requested to pay an amount of Rs.769/- towards cost of information. He has produced copy of information furnished to the appellant.

The appellant did not choose to attend the hearing nor filed affidavit offering his version.

Since information is furnished, **the Appeal is closed.**
