## **ORDER**

**Sri A.Gopi Maheshwar, R/o Hyderabad District** has filed a Complaint dated **09-03-2020** which was received by this Commission on **12-03-2020** for not getting the information sought by him from the PIO / O/o The Joint Director of Agriculture, Agriculture Department, Khammam, Khammam District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated **16-12-2019** under Sec.6(1) of the RTI Act, 2005, before the PIO seeking following information:

1. In this connection I received a letter No. N.Dis Endt.No.A-II(5)33/2019 Date 17/01/2019 from the Commissioner & Director of Agriculture Hyd. (Copy enclosed) for the process of my application I have to submit NDC (Non drawl Certificate ) of my late father where he last worked ( i.e. Khammam).

2. As per the letter of Commissioner & Director of Agriculture, Hyd I requested through the letter to The Joint Director of Agriculture, Khammam Dated 25/01/2019 (Copy enclosed with their Acknowledgement Postal). Not received any response till date.

3. Again I requested to DAO Khammam through my letter dated 08/01/2019 (Copy Enclosed)me also requested by emails, but not received any response.

Therefore I request you to kindly look into the matter and arrange the NDC(Non drawl Certificate of my late father A.Satyanarayana A.O. Retd Khammam) at the earliest which will helpful to me and my family as one year coming to end, in this process.

The PIO has not furnished the sought information to the complainant.

As the complainant did not receive the sought information from the PIO even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him.

The Complaint was taken on file and notices were issued to the parties concerned for hearing on **16-05-2022**.

On **16-05-2022** the case is called. The Complainant is present. The Public Information Officer, O/o the Joint Director of Agriculture, Khammam is absent. The Assistant Public Information Officer is present on behalf of the Public Information Officer.

The Complainant submitted that he has received the sought information from the Public Information Officer after issue of instructions by the Commissioner of Agriculture.

The representative of the Public Information Officer filed affidavit of the Public Information Officer submitting that the sought information was furnished to the Complainant on 22-10-2021.

The record goes to show that the 6(1) application was filed on 16-12-2019 seeking nondrawal certificate of his late father for drawing of medical reimbursement to his Mother and the Public Information Officer has furnished sought information to the appellant on 22-10-2021 with a delay of nearly two years.

Since information is furnished, **the Complaint is closed.**

Issue **show cause notice** to Public Information Officer for not furnishing the sought information to the appellant within the stipulated time. The action on the show cause notice shall be dealt with separately.
