## **ORDER**

Sri SHARMILA THOOMU, R/o Khammam District filed 2<sup>nd</sup> appeal dated 11-03-2020 which was received by this Commission on 16-03-2020 for not getting the information sought by him from the PIO / O/o The Superintending Engineer/A &P KTPS, (O&M), Palvancha Bhadradi Kothagudem District and 1<sup>st</sup> Appellate Authority / O/o The Chief Engineer/A &P KTPS, (O&M), Palvancha Bhadradi Kothagudem District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 07-12-2019 under Sec.6(1) of the RTI Act, 2005, before the PIO seeking the following information:

1. ది. 30-10-2019 న దావా విజయ S/o భాస్కర రావు పై కోర్టులో (కోర్టుగాడెం) లో 3 వెలల ఇక్క పడింది. అతను పరారి లో ఉన్నాడు. అరెస్ట్ వారెంట్ పెండింగ్ లో ఉంది ఇతని పై దర్య తీసుకోనమని మీకు నేను ధరఖాస్తు చేసినాను. దీనిపై నేటి వరకు మీరు తీసుకోనిన దర్య నివేదిక ఇవ్వగలరు.
2. ఇతను సంతకం చేసినటువంటి హాజరు పట్టిక 18-10-2019 నుండి నేటి వరకు ఇవ్వగలరు.
3. దావా విజయ సెలవు మంజూరి కొరకు చేసినటువంటి 18-10-2019 నుండి దరఖాస్తులు దానిపై మీరు తీసుకోనిన నిర్ణయం ఇవ్వగలరు. దీనికి సంబంధించిన ఉత్తర ప్రత్యుత్తరాలు మొత్తం ఇవ్వగలరు.
4. సివిల్ కోర్టులో ఇక్క పక్షాలుంటే ఉద్యోగి పై మీ సంస్థ నిబంధనల ప్రకారము ఉద్యోగము నుండి తొలగిస్తారా లేదా మాకు సమాచారము తెలియజేయగలరు.

**జరపరిచినవి:- తేది 30-10-2019 కంప్లెంట్ కాపీ జరపరిచినాను.**

The Public Information Officer through letter No. SE/A&P/Public Information Officer/KTPS(O&M)/AM(HR)/ADM/RTI/D.No.190/19 dated 31-12-2019 furnished reply to the appellant.

Stating that the information furnished by the Public Information Officer is incomplete / incorrect, the appellant filed 1<sup>st</sup> appeal dated 07-01-2020 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought.

As per the records enclosed it is noticed that the 1<sup>st</sup> Appellate Authority had failed to hear the case and pass appropriate orders on the 1<sup>st</sup> appeal filed before him.

As the appellant did not get information from the Public Information Officer, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to arrange to furnish the information sought by him.

The 2nd Appeal was taken on file and notices were issued to the parties concerned for hearing **on 10-05-2022**.

**On 10-05-2022** the case is called. The Appellant is absent. The Public Information Officer / Superintending Engineer, KTPS (O&M), Palwancha, Kothagudem is absent. The Assistant Manager is present on behalf of the Public Information Officer. The 1st Appellate Authority is absent.

The representative of the Public Information Officer filed affidavit of the Public Information Officer submitting that the factual information was furnished to the appellant on 31-12-2019 by RPAD. He has produced copy of information furnished to the appellant along with dispatch proof.

The appellant did not choose to attend the hearing nor filed affidavit offering his version.

Since information is furnished, **the Appeal is closed.**
