## ORDER

Sri Pallela Devaraju, R/o Karimnagar District filed 2<sup>nd</sup> appeal dated 17-03-2021 which was received by this Commission on 18-03-2021 for not getting the information sought by him from the PIO / 1) O/o The Road Transport Authority, Thimmapur Mandal, ,Karimnagar District-505001 2) O/o The Tahsildar, Thimmapur Mandal, Karimnagar District and 1<sup>st</sup> Appellate Authority / O/o The District Collector, Karimnagar District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 18-01-2021 under Sec.6(1) of the RTI Act, 2005, before the PIO seeking the following information:

The Public Information Officer through Letter No. H2/105/2021 dated 11-02-2021 transferred the application U/s 6(3) to the Public Information Officer, 1) O/o The Road Transport Authority, Thimmapur Mandal, ,Karimnagar District-505001 2) O/o The Tahsildar, Thimmapur Mandal, Karimnagar District for furnishing the sought information.

The Public Information Officer has not furnished the sought information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1<sup>st</sup> appeal dated 18-02-2021 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought.

As per the records enclosed it is noticed that the 1<sup>st</sup> Appellate Authority had failed to hear the case and pass appropriate orders on the 1<sup>st</sup> appeal filed before him.

As the appellant did not get information from the Public Information Officer, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to arrange to furnish the information sought by him.

The 2nd Appeal was taken on file and notices were issued to the parties concerned for hearing **on 17-05-2022**.

**On 17-05-2022** the case is called. The Appellant is absent. The Public Information Officer / Naib Tahsildar, Thimmapur Mandal, Karimnagar District is absent. The Naib Tahsildar, Kothapally Mandal is present on behalf of the Public Information Officer. The 1st Appellate Authority is absent.

The record goes to show that the 6(1) application was filed on 18-01-2021 and the Public Information Officer has not furnished sought information to the appellant even after more than one year.

The Commission directs the Public Information Officer to furnish sought information to the appellant **within (15) days** from the date of receipt of this order and submit compliance to the Commission.

With the above direction, **the Appeal was adjourned to 23-05-2022**.

**On 23-05-2022** the case is called. The Appellant is absent. The Public Information Officer, O/o the Road Transport Authority, Thimmapur, Karimnagar District is absent. He has sent letter of absence while deputing the Senior Assistant to attend the hearing on behalf of the Public Information Officer. The 1st Appellate Authority is absent.

The representative of the Public Information Officer submitted that the sought information was furnished to the appellant on 8-3-2021 by registered post.

The appellant did not choose to attend the hearing nor filed affidavit offering his version.

Since factual information is furnished, **the Appeal is closed**.
