ORDER

Sri CH. VEERASWAMY, H.no.7-9-44/3, Sri Ram Nagar Colony, Panagal Road, Nalgonda Town and District-508001 has filed a Complaint dated 23-03-2022 which was received by this Commission on 24-03-2022 for not getting the information sought by him from the PIO / O/o The Commissioner of Employment and Training, Government I.T.I Mallepally Campus, Hyderabad-500057.

2. The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated 16-12-2021 before the PIO requesting to furnish the information under Sec.6(1) of the RTI Act, 2005, on the following points mentioned in his application.

1. **What are the qualifications required for promotion to the post of ATO Costume Design and Dress Making (CDDM).**
2. **Who will be considered for promotion to the post of ATO Costume Design and Dress Making (CDDM) whether workshop attender is having passed I.T.I Dress Making or I.T.I Cutting and Tailoring.**
3. **What are the qualifications required for promotion to the post of ATO Cutting and Tailoring.**
4. **Who will be considered for promotion to the post of ATO Cutting and Tailoring whether workshop Attenders having passed I.T.I Cutting and Tailoring or I.T.I Costume Design and Dress Making (CDDM).**

As such, I am submitting this application under Sec.6 of Right to information Act 2005. I am paying Rs.10/- by way of court fee stamps as per Rule 3© of the above mentioned rules, ready to pay the required costs for the issuance of the above copies required by Rule 4 of the above mentioned Rules.

Therefore, the Hon'ble information Officer under Right to Information Act may be pleased to order for issuance of the above mentioned information to me.

3. The Public Information Officer has not furnished information to the Complainant.

4. As the Complainant did not receive the required information from the PIO even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

The Complainant was taken on file and notices were issued to the parties concerned for hearing on **13-06-2022**.

On **13-06-2022** the case is called. The Complainant is present. The Public Information Officer / Deputy Director, O/o the Commissioner of Employment and Training, Hyderabad is present.

The Complainant submitted that he did not receive the sought information from the Public Information Officer.

The Public Information Officer submitted that the sought information was furnished to the Complainant vide letter No.R1/RTI/3582/2021 dated 10-03-2022.

Heard both the parties and perused the records.

The Commission observed that the Public Information Officer has not furnished complete information to the Complainant.

The Commission directs the Public Information Officer to furnish complete information to the Complainant **within (15) days** from the date of receipt of this order and submit compliance to the Commission.

With the above direction, **the Complaint is adjourned** for compliance by the Public Information Officer.
