## **ORDER**

Sri SRINATH RASA, R/o Yadadri Bhongir District filed 2<sup>nd</sup> appeal dated 10-01-2020 which was received by this Commission on 13-01-2020 for not getting the information sought by him from the PIO / O/o The Assistant Secretary to Government, ITE & C Department, D-Block, 5<sup>th</sup> Floor, BRKR Bhavan, Hyderabad and 1<sup>st</sup> Appellate Authority / O/o The Assistant Secretary to Government, ITE & C Department, D-Block, 5<sup>th</sup> Floor, BRKR Bhavan, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 09-09-2019 under Sec.6(1) of the RTI Act, 2005, before the PIO seeking certain information.

The Public Information Officer through letter No. 411337 / ITE&C/Admn/2019 dated 10-10-2019 furnished the sought information to the appellant.

Stating that the information furnished by the Public Information Officer is incomplete / incorrect, the appellant filed 1<sup>st</sup> appeal dated 05-11-2019 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought.

As per the records enclosed it is noticed that the 1<sup>st</sup> Appellate Authority had failed to hear the case and pass appropriate orders on the 1<sup>st</sup> appeal filed before him.

As the appellant did not get information from the Public Information Officer, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to arrange to furnish the information sought by him.

The 2nd Appeal was taken on file and notices were issued to the parties concerned for hearing on 18-04-2022.

On 18-04-2022 the case is called. The Appellant is absent. The Public Information Officer / Assistant Secretary to Govt., IT&C Department, T.S.Secretariat, Hyderabad is present. The 1st Appellate Authority is absent.

The Public Information Officer submitted that the sought information was furnished to the appellant point wise on 10-10-2019 by speed post.

The appellant did not choose to attend the hearing nor filed affidavit offering his version. The appellant in his second appeal admitted to have received information but stated to be incomplete. He however did not disclose as to what information is incomplete.

Since exhaustive information is furnished, the Appeal is closed.
