ORDER

Smt P. SAROJINI, R/o Warangal District filed 2nd appeal dated 07-05-2020 which was received by this Commission on 18-05-2020 for not getting the information sought by her from the PIO / O/o The Kakatiya Urban Development Authority(KUDA), Warangal District and 1st Appellate Authority / O/o The Kakatiya Urban Development Authority(KUDA), Warangal District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **26-07-2019** under Sec.6(1) of the RTI Act, 2005, before the PIO seeking the following information:

I, Sarojna, w/o. Sri. P. kishan, D/o. Late. Sri Somatrathi Kashinadham, Age: 60years, that I am the owner and possessors of the landed property located in sy. no. 611 A to an extent of 2.05guntas and sy. 631 to an extent of 0.30 guntas, situated at Urus Shivar, Warangal District. The landed properties were converted into the possession by the Revenue Authorities etc.. The landed properties were submerged in the Bhadrakali Tank Reerevior as a result the said landed properties submerged in the Bhadrakali Tank water and the said lands have been lying in the same condition since 1997. I was not faced with any kind of compensation to make good for less faced by me from the government. I have approached the Revenue Dept.

As such I approached the court of law and obtained Degree in o.s. 27/04&OS.32 in direction to the authorities concerned to remove the bund shore from the said scheduled property with six months from the date of judgement. In case of failure the plaintiff is permitted to remove the bund shore from the suit scheduled property through the process of the court and also to receive Rs. 2,50,000 in the shape of compensation.

But the authorities concerned did not honour the court orders it compelled me to pay Rs. 2,50,000 through E.P. No. 112/18 and E.P. No. 226/18 for the implementations of the judgement.

The same situation was already submitted to the Hon'ble Chief Minister cell by Registered Post and through Fax vide reference cited. I have not received any kind of response 1st and 2nd time either from the Chief Minister office the authorities concerned even through a period of more than one month has passed.

The Govt is bent upon ensuring smooth, effective, prompt transparent reliable and meagre administrations. The policies of the Govt. are not being implemented by the bearacrafts yielding the prestage of the Govt:

I therefore request you kindly to direct the authorities concerned to supply me the information passed by the Chief Minister under section 6 and 7 of the R.T.I. act 2005 within stipulated time within 7 days.

I enclose herewith the postal order for Rs. 20.00 towards fee and charges for xerox.

The Public Information Officer through Letter No. C4/2430/2019 dated 07-11-2019 transferred the application U/s 6(3) to the Public Information Officer, O/o The Kakatiya Urban Development Authority (KUDA), Warangal District for furnishing the sought information.

The Public Information Officer has not furnished the sought information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1st appeal dated **03-09-2019** before the 1st Appellate Authority requesting him to furnish the information sought.

As per the records enclosed it is noticed that the 1st Appellate Authority had failed to hear the case and pass appropriate orders on the 1st appeal filed before him.

As the appellant did not get information from the Public Information Officer, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him.

The 2nd Appeal was taken on file and notices were issued to the parties concerned for hearing **on 18-04-2022**.

On 18-04-2022 the case is called. The Appellant is absent. The Public Information Officer, O/o the Kakatiya Urban Development Authority, KUDA, Hanumakonda is absent. The 1st Appellate Authority is absent.

The record goes to show that the 6(1) application was filed on 26-07-2019 and the Public Information Officer has not furnished sought information to the appellant even after 1 ½ years.

The Commission directs the Public Information Officer to furnish sought information to the appellant **within (15) days** from the date of receipt of this order and submit compliance to the Commission.

With the above direction, the Appeal **is adjourned** for compliance by the Public Information Officer.
