## ORDER

Sri K. VENKATA NARAYANA, R/o Warangal District filed 2<sup>nd</sup> appeal dated 13-05-2020 which was received by this Commission on 21-05-2020 for not getting the information sought by him from the PIO / 1) O/o The Commissioner, Greater Warangal Municipal Corporation, Warangal District 2) O/o the Vice Chancellor, Kakatiya Urban Development Authority(KUDA), Warangal District and 1<sup>st</sup> Appellate Authority / O/o the Vice -Chairman, Kakatiya Urban Development Authority(KUDA), Warangal District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 02-12-2019 under Sec.6(1) of the RTI Act, 2005, before the PIO seeking the following information:

The Public Information Officer has not furnished the sought information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1<sup>st</sup> appeal dated 07-01-2020 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought

As per the records enclosed it is noticed that the 1<sup>st</sup> Appellate Authority had failed to hear the case and pass appropriate orders on the 1<sup>st</sup> appeal filed before him.

As the appellant did not get information from the Public Information Officer, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to arrange to furnish the information sought by him.

The 2<sup>nd</sup> Appeal was taken on file and notices were issued to the parties concerned for hearing on 18-04-2022.

On 18-04-2022 the case is called. The Appellant is absent. The Public Information Officer, O/o the Municipal Commissioner, GWMC, Warangal is present. The 1<sup>st</sup> Appellate Authority is absent.

The representative of the Public Information Officer submitted that the appellant was informed on 06-03-2020 that the filed related is under circulation.

The appellant did not choose to attend the hearing nor filed affidavit offering his version.

The Commission directs the Public Information Officer to furnish the latest factual status of the matter to the appellant **within (15) days** by RPAD from the date of receipt of this order and submit compliance to the Commission.

With the above direction, **the Appeal is closed.**
