ORDER

Sri B. RAJIAH, R/o Jangaon District has filed a Complaint dated Nil which was received by this Commission on **01-06-2020** for not getting the information sought by him from the PIO / O/o The Deputy Tahsildar, Lingalaghanpur, Jangaon District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated **22-07-2019** under Sec.6(1) of the RTI Act, 2005, before the PIO seeking following information:

The PIO has not furnished the sought information to the complainant.

As the complainant did not receive the sought information from the PIO even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him.

The Complaint was taken on file and notices were issued to the parties concerned for hearing on **9-11-2021**.

On **9-11-2021** the case is called. The complainant is absent. The PIO / O/o. the Tahsildar, Lingalaghanpur Mandal, Jangaon District is absent.

The record goes to show that the 6 (1) application was filed on 22-07-2019 and no information is furnished by the PIO so far.

The Commission directs the PIO to furnish information to the Complainant within (15) days from the date of receipt of this order and submit compliance to this Commission.

With the above direction, the Complaint was **adjourned to 27-04-2022**.

On **27-04-2022** the case is called. The Complainant is present. The Public Information Officer / Naib Tahsildar, Lingalaghanpur Mandal, Jangaon District is absent. The Senior Assistant is present on behalf of the Public Information Officer.

The case was earlier heard and adjourned on 09-11-2021 with a direction to Public Information Officer to furnish information to the Complainant within (15) days from the date of receipt of this order and report compliance to the Commission.

The Complainant submitted that the Public Information Officer has not furnished sought information to him.

The representative of the Public Information Officer filed affidavit of the Public Information Officer submitting that his predecessor has furnished the information to the Complainant on 18-11-2021 vide letter No.A/557/2021 by registered post dated 22-11-2021.

Heard both the parties and perused the records.

The Commission observed that the Public Information Officer has furnished factual information hence the Complaint **is closed**.

Issue **show cause notice** to then Public Information Officer for not furnishing the sought information to the appellant within the stipulated time. The action on the show cause notice shall be dealt with separately.
