ORDER

Sri D. BAKKAI AH, R/o Bhupalapalli District has filed a Complaint dated **28-05-2020** which was received by this Commission on **02-06-2020** for not getting the information sought by him from the PIO / O/o The District Agriculture Officer, Mulugu District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated **24-02-2020** under Sec.6(1) of the RTI Act, 2005, before the PIO seeking following information:

The PIO has not furnished the sought information to the complainant.

As the complainant did not receive the sought information from the PIO even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him.

The Complaint was taken on file and notices were issued to the parties concerned for hearing on **16-05-2022**.

On **16-05-2022** the case is called. The Complainant is absent. The Public Information Officer / Assistant Director of Agriculture, Eturunagaram, Mulugu District is present.

The Public Information Officer submitted that the Complainant was informed factual position orally about queries raised by him in his 6(1) application, but no written information was furnished.

The Complainant did not choose to attend the hearing nor filed affidavit offering his version.

The Commission directs the Public Information Officer to furnish factual status of matter to the Complainant **within (15) days** from the date of receipt of this order and submit compliance to the Commission.

With the above direction, **the Complaint is closed.**

The Public Information Officer is **warned** to be prompt while dealing with application filed under RTI Act, 2005 and strictly adhere to the stipulated time limits with reference to Sec.7(1) of the RTI Act, 2005.
