## **ORDER**

Sri V.S.Reddy, R/o. Secunderabad has filed a Complaint dated 15-04-2019 which was received by this Commission on 15-04-2019 for not getting the information sought by him from the PIO / O/o. the Deputy Registrar of Cooperative Societies, Secunderabad Division, 5<sup>th</sup> Floor, Gruha Kalpa, M.J.Road, Hyderabad.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated 06-02-2019 under Sec.6(1) of the RTI Act, 2005, before the PIO seeking following information:

**LIST OF DOCUMENTS REQUESTED: CARC: 9/2011 & CTA: 26/2018**

1. *With reference to my payment-receipt No. 350, dt. 19-02-1987*
  - a. List of members-cum-shareholders taken over by the group/Society of members of AWHO Colony (Secunderabad Project) from Army Welfare Housing Organisation, New Delhi, on formation as a local (cooperative?) housing society, between 1986-92.
  - b. Extract of my name (if) figuring in the said list as one of the member cum shareholder of the newly formed housing society
  - c. Reasons, recorded or otherwise, if my name did not figure in the said initial list of AWCH-Society, as taken over from AWHO, New Delhi (as in (a) above).
  - d. If the Society was registered in 1991 or 1992, as claimed :
    - a. Copy of Form-A or Form-AA (list of *ab initio* members) submitted by the group/society comprising AWHO members (of Secunderabad Project) to the Registrar of Co-operative Societies, along with their application for registration (of society) u/s 6 and Rule 3 of APCS Act/Rules.
    - b. Extract of my name as (and if) appearing in the said Form-A/AA. Reasons if not appearing in the said list.
3. *With reference to my payment-receipt No. 5978 dt. 23-04-1997:*
  - a. Compliance record of Section 19 ( sub sections 2A to 5 ), Rule 12-A and 14, your byelaw numbers 5,6,7,8 and 9 including the corresponding resolutions/minutes of Managing Committee or General Body meetings on the conferment/refusal of membership and shareholding on me, including the type of membership, effective date and due intimation to me, post the cited payment.
  - b. If the above is in the affirmative, copies of my membership card, share-certificate, the corresponding extract from the Register-of-Members. If in negative, reasons there for.
4. *In respect of transactions with me by the Society:*
  - a. If no membership or share-holding were conferred on me as per the data and criteria specified as above, the necessary permission obtained from the Registrar of Co-operative Societies, for entering into many transactions with me between 1986 and 2018, as mandated u/s 48 and Rule 42 of AP/TS CS Act/Rules, 1964.
  - b. Record of correspondence that transpired on items 1 to 4(a) above, on the cited memberships and transactions
5. CC of Certificate-of-Registration obtained from RCS by the Society in their favour, including the record of their criteria-eligibility stipulated u/r 12 (2) (e) of AP CS Act.
6. Record pertaining to the take-over of my flat No. J-4 and its connected records by the Society, from AWHO New Delhi (if any), including the layout-approval, building-permission and occupancy-certificate from the civic authorities.
7. Record pertaining to title, or ownership or possession acquired in by the Society, in respect of my flat No. J-4, at any time between 1986 and 2018, so as for them to be eligible and competent to transfer such flat in my favour or such other owner who held it in the said period (if any).
8. Advice and opinion on the cited transactions vis-à-vis memberships

**NOTE:** The above information is to be sourced, accessed and provided from the records of the designated presenting officer/Dy.Registrar as relevant and material to CTAs 27, 73/2009 and 26/2018. Where information does not exist, please state the same with clarity and precision.

The PIO has not furnished the sought information to the complainant.

The Public Information Officer through Letter No. 1016/2015-RTI dated 26-02-2019 transferred the application U/s 6(3) to the Public Information Officer, O/o The Deputy Registrar of Cooperative Societies, Secunderabad Division, 5<sup>th</sup> Floor, Gruha Kalpa, M.J.Road, Hyderabad for furnishing the sought information.

As the complainant did not receive the sought information from the PIO even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him.

The Complaint was taken on file and notices were issued to both the parties for hearing on 13-09-2021.

On 13-09-2021 the case is called. The Complainant is present. The PIO / Assistant Registrar, O/o. the Deputy Registrar of Cooperative Societies, Secunderabad, Gruhakalpa, 5<sup>th</sup> Floor, Hyderabad is present.

The Complainant submitted that he did not receive the sought information from the PIO so far.

The PIO submitted that the 6 (1) applications of the complainant were filed prior to 2019 and she joined in 2020 and as such, she is not aware of the RTI applications filed by the complainant. She has however assured to furnish the sought information to the complainant within (45) days.

Heard both the parties and perused the records.

The Commission observed that the complainant has filed nearly (20) 6 (1) applications seeking various records in respect of Air Force Officers Cooperative Housing Society Ltd., Vayupuri, Medchal Malkajgiri District. The submission of the PIO made vide reference dated 27-01-2021 is that in most of the cases the complainant was furnished factual detailed information on 02-05-2019 and as the complainant is not satisfied with the information furnished by the PIO, he requested the Commission to advise the complainant to inspect the records sought in all the cases.

In view of the above submission by the PIO, the complainant was asked by the Commission to inform as to what specific records are required to him.

The Complainant submitted that as the Public Information Officer did not respond to his earlier applications, the same information is being sought by him time and again in various ways by filing umpteen applications. Finally, the complainant summed up the information sought by him in all the applications and submitted a representation to the Commission containing concise and consolidated records required to him with a request to arrange the same from the PIO.

Therefore, while enclosing a copy of representation submitted by the Complainant, the Commission directs the PIO to furnish the available information, while indicating reasons for non-availability of information if any, to the complainant within (45) days from the date of receipt of this order and submit compliance to the Commission.

With the above direction, the Complaint was adjourned to **23-06-2022**.

**On 23-06-2022** the case is called. The Complainant is absent. The Public Information Officer / Assistant Registrar, O/o the Deputy Registrar of Cooperative Society, Secunderabad Division, Hyderabad is present.

The Public Information Officer submitted that in compliance with the orders of the Information Commission, in spite of cases heard by the Commission on 13-9-2021, the factual information was furnished to the Complainant on 28-10-2021 on (10) points.

The Complainant did not choose to attend the hearing nor filed affidavit offering his version.

Since information is furnished, **the Complaint is closed.**
