ORDER

Sri MOHD ASHRAF, R/o Kumuram Bheem District filed 2nd appeal dated 28-05-2020 which was received by this Commission on 03-06-2020 for not getting the information sought by him from the PIO / O/o The Secretary, Agriculture Market Committee, Asifabad, Komaram Bheem District and 1st Appellate Authority / O/o The Secretary, Agriculture Market Committee, Asifabad, Komaram Bheem District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 01-04-2020 under Sec.6(1) of the RTI Act, 2005, before the PIO seeking the following information:

2. RTI Act కి సంబంధించిన REGISTER 1 & 2 ను ఇవ్వగలరు. అఫీసుకి వచ్చిన 6 (1) APPLICATIONS & 19 APPEAL ORDERS లను 2 (J) ప్రకారం 01-01-2017 నుండి నేటి వరకు ఇవ్వగలరు.
3. మీ office నుండి ఇచ్చిన MEMOS, ప్రతులు, circulars , order, AUDIT PARAS ,Disiplinary proceedings లను 1-11- 2017 నుండి నేటి వరకు ఇవ్వగలరు.
4. మీ కార్యాలయానికి Agriculture & Cooperation(MKT.I) Govt.Memo.No.2599/Mktg.I/2019, dt. 30-04-2019 ప్రకారం AMC 2nd Appointment లో సూచించిన Reservation ఏమిటి.? మీరు పంపించిన proposal ఫైల్ ను ఇవ్వగలరు.
5. మీ కార్యాలయానికి Agriculture & Cooperation(MKT.I) Govt.Memo.No.2599/Mktg.I/2019, dt. 30-04-2019 ప్రకారం AMC 2nd Appointment లో సూచించిన Reservation ఏమిటి.? ఎప్పటి వరకే నియమించాలి.? ఇంతవరకు పోషడానికి గల కారణాలు తెలుపగలరు.
6. మీ కార్యాలయంలో గల బ్యాంకు అకౌంట్ల statements, vouchers, acquaintanceలను 2014 నుండి ఇవ్వగలరు.
7. మీ కార్యాలయంలో గల బ్యాంకు అకౌంట్లనుండి ఇతర మార్కెట్ కమిటీలకు డబ్బులు పంపినచో వాటి వివరాలను ద్వారా పోసిషన్ తోపాటు ఇవ్వగలరు.

The Public Information Officer through letter No. AGM/Asifabad/R.T.I/2012-13/202 dated 08-04-2020 furnished the sought information to the appellant.

Stating that the information furnished by the Public Information Officer is incomplete / incorrect, the appellant filed 1st appeal dated 20-04-2020 before the 1st Appellate Authority requesting him to furnish the information sought.

As per the records enclosed it is noticed that the 1st Appellate Authority had failed to hear the case and pass appropriate orders on the 1st appeal filed before him.

As the appellant did not get information from the Public Information Officer, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him.

The 2nd Appeal was taken on file and notices were issued to the parties concerned for hearing on **16-05-2022**.

On 16-05-2022 the case is called. The Appellant is absent. The Public Information Officer / Secretary, Agriculture Market Committee, Asifabad is absent. The 1st Appellate Authority is absent.

The record goes to show that the 6(1) application was filed on 1-4-2020 and the Public Information Officer has furnished point wise factual information to the appellant 8-4-2020.

The appellant did not choose to attend the hearing nor filed affidavit offering his version.

Since information is furnished, **the Appeal is closed.**

Issue **show cause notice** to Public Information Officer for not attending hearing before the Commission. The action on the show cause notice shall be dealt with separately.
