## ORDER

Sri Pallela Devaraju, R/o Karimnagar District filed 2<sup>nd</sup> appeal dated 24-03-2021 which was received by this Commission on 27-03-2021 for not getting the information sought by him from the PIO / O/o The District Collector, Karimnagar District and 1<sup>st</sup> Appellate Authority / O/o The District Collector, Karimnagar District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 18-01-2021 under Sec.6(1) of the RTI Act, 2005, before the PIO seeking the following information:

The Public Information has not furnished sought information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1<sup>st</sup> appeal dated 18-02-2021 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought.

As per the records enclosed it is noticed that the 1<sup>st</sup> Appellate Authority had failed to hear the case and pass appropriate orders on the 1<sup>st</sup> appeal filed before him.

As the appellant did not get information from the Public Information Officer, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to arrange to furnish the information sought by him.

The 2<sup>nd</sup> Appeal was taken on file and notices were issued to the parties concerned for hearing on 17-05-2022.

**On 17-05-2022** the case is called. The Appellant is absent. The Public Information Officer, O/o the District Collector, Karimnagar is absent. The Naib Tahsildar, Kothapally Mandal is present on behalf of the Public Information Officer. The 1st Appellate Authority is absent.

The representative of the Public Information Officer submitted that the sought information was furnished to the appellant vide letter No.A5/RTI/2021 dated 3-4-2021 and the same was acknowledged by the appellant on 06-04-2021 by hand. The Public Information Officer has produced copy of information furnished duly acknowledged by the appellant.

The appellant did not choose to attend the hearing nor filed affidavit offering his version.

Since information is furnished, **the Appeal is closed.**

Issue **show cause notice** to Public Information Officer for not attending hearing before the Commission. The action on the show cause notice shall be dealt with separately.
