ORDER

Sri Kolapuri Balaiah, R/o. Karimnagar District has filed a Complaint dated 01-05-2018 which was received by this Commission on 01-05-2019 for not getting the information sought by him from the PIO / The Naib Tahsildar, Choppadandi Mandal, Karimnagar District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated 23-12-2017 under Sec.6(1) of the RTI Act, 2005, before the PIO seeking following information:

The PIO through Lr.No. C/4371/2017 dated 24-01-2018 informed the complainant that the sought file is not traced in the records.

As he did not get information, the complainant preferred this Complaint before this Commission requesting to arrange to furnish the information sought by him.

The Complaint was taken on file and notices were issued to both the parties for hearing on 31-03-2021.

On 31-03-2021 the case was called and adjourned with a direction to rebuild the file and furnish information to the complainant within two months from the date of receipt of that said order and submit compliance.

On 27-09-2021 the case is called again. The Complainant is absent. The PIO / O/o. the Tahsildar, Choppadandi Mandal, Karimnagar District is absent. The APIO / Senior Assistant, O/o. the Tahsildar, Choppadandi Mandal is present.

The APIO filed affidavit of the PIO submitting that a memo was issued to the record in charge on 21-06-2021 to trace out the concerned file but the record in charge conveyed on 16-07-2021 that after extensive search also the file could not be traced.

The Commission took a serious view on the non implementation of the Commission order and directs the PIO again to make thorough search and furnish the information **within (30) days** from the date of receipt of this order.

With the above direction, the Complaint was **adjourned to 26-04-2022**.

On 26-04-2022 the case is called. The Complainant is absent. The Public Information Officer / Naib Tahsildar, Choppadandi Mandal, Karimnagar District is present.

The case was earlier heard and adjourned on **27-09-2021** with a direction to Public Information Officer to furnish sought information to the appellant within (30) days from the date of receipt of this order and report compliance to the Commission.

The Public Information Officer submitted that he joined recently in January, 2022. But as per records his predecessor has already furnished ROR file to the Complainant on 11-10-2021 within time limit of (30) days given by the Commission on 27-09-2021.

The Complainant did not choose to attend the hearing nor filed affidavit offering his version.

Heard the Public Information Officer and perused the records.

The then Public Information Officer has reported to the Commission on 16-12-2021 submitting that the ROR file was traced and furnished the same to the Complainant on 11-10-2021. He further submitted that the orders of the Commission have been complied with and requested to close the Complaint.

In view of the above submission of the then Public Information Officer, as the information is furnished, **the Appeal is closed**.

Issue **show cause notice** to the then Public Information Officer for not furnishing the sought information to the appellant within the stipulated time. The action on the show cause notice shall be dealt with separately.
