ORDER

DR.TGK MAHADEV, R/o Secunderabad has filed a Complaint dated **15-06-2020** which was received by this Commission on **17-06-2020** for not getting the information sought by him from the PIO / O/o The Dy.Registrar-CS, Vth Floor, Gruhakalpa, M.J.Road, Hyderabad.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated **06-07-2019** under Sec.6(1) of the RTI Act, 2005, before the PIO seeking following information:

1. Their application for winding-up
2. The relevant General Body resolution
3. Formal or informal approval from your office/Department
4. The opinion and decisions by your office/department
5. The record of opportunity given by you for making their representation, including that of dissenters and objectors
6. Compliance-record of the requisite legal formalities for windup
7. The relevant order directing it to be wound up, by your office or such other competent authority, including correspondence
8. The relevant section or sub section, rule of relevant statute, under which the above steps were followed or complied with
9. Copy of such order passed u/ s 64 of TS CS Act
10. Whether any liquidator has been appointed for wind-up
11. Whether such appointment is mandatory or discretionary
12. Any opportunity given to the affected parties in respect of the presentment of their reports or claims in respect of assets and liabilities of the Society (for wind-up)
13. Status/disposal of disputes, arbitrations, lawsuits, and claims in various courts-of-law subsisting against the Society, including my objections on record
14. Steps taken by the liquidator and proceedings (for wind-up)
15. Compliance-record of steps prescribed u/s 65
16. Whether the said Society was registered u/s 8 of Co-op. Act, or whether Section 80 is operative against the Society
17. Any other relevant information on the stated wind-up
18. Your advice and opinion on the subject matter/information.

The PIO has not furnished the sought information to the complainant.

As the complainant did not receive the sought information from the PIO even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him.

The Complaint was taken on file and notices were issued to the parties concerned for hearing on **25-04-2022**.

On **25-04-2022** the case is called. The Complainant is absent. The Public Information Officer / Assistant Registrar, O/o the Deputy Registrar of Cooperative Societies, Secunderabad Division, Hyderabad is present.

The Public Information Officer submitted that she has requested to grant (10) days time to enable her to furnish information to the Complainant.

The Complainant did not choose to attend the hearing nor filed affidavit offering his version.

The Commission directs the Public Information Officer to furnish sought information to the Complainant as assured **within (10) days** by RPAD from the date of receipt of this order and submit compliance to the Commission.

With the above direction, **the Complaint is adjourned** for compliance by the Public Information Officer.
