ORDER

Smt.VARALAKSHMI, R/o Secunderabad has filed a Complaint dated 15-06-2020 which was received by this Commission on 17-06-2020 for not getting the information sought by him from the PIO / O/o The Dy.Registrar Co-op. Societies, Vth Floor, Gruhakalpa, M.J.Road, Hyderabad.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated 31-07-2019 under Sec.6(1) of the RTI Act, 2005, before the PIO seeking following information:

- from your records (including Society).
1. Records specified in para 1 i to ix, in my RTI application supra
 2. Reasons/grounds for not responding to said application
 3. Whether the Society applied for any winding-up (with records)
 4. Whether your office/department have accorded permission for such winding-up at any time . If yes, following records:
 - a. As u/s 64 (1) of TS CS Act 1964 (post any inquiry)
 - b. As u/s 64 (2) of TS CS Act (on Registrar's own motion)
 - c. Whether any liquidator appointed/mooted . If yes, records
 - d. Whether to be liquidated under any other provision
 5. Status/disposal of my applications seeking membership ,
 - a. From Society Management since 2002
 - b. From Dl.C.O.-Sec'bad , since 2003
 - c. Whether I am a deemed member as per the legal provisions
 - d. If not, the requisite intimation/clarification on the matter
 - e. Whether my present status is that of a member /non member
 - f. If a non member, compliance record u/s and u/r
 6. Whether the Society has sought or applied permission from your office for floating a separate Association/RWA (if so, record),
 - a. Whether such association is bound by the byelaws of AWHO
 - b. Whether such association is bound by its previous byelaws
 - c. Whether they obtained permission from AWHO (or not required)
 - d. The legal positions under which such RWA was floated
 7. Whether the Society deposed in WP No. 3069/2015 of Hon'ble High Court of TS to the effect that land and buildings have been alienated by AWHO to AWCH Society and in turn to the allottee-owners vide Exhibit No. 279 from the running index of documents attached (including cc of exhibit)
 - a. The convening-order, terms -of-reference , the inquiry-proceeding and findings of a special committee formed for the purpose of inquiring into the complaints of irregularities, malpractices and violations committed by Sri ARK Reddy, former President vide the resolution /minute No..... dt.01-01-2011 (in certified copies)
 - b. If inquiry not conducted/progressed, reasons there for
 9. Record pertaining to handing/taking-over of housing assets with connected records from AWHO to AWCH Society, including the flat No. j-4 with its schedule of property.
 10. The title-deeds and link-documents requested by me from these two above entities, which were demanded by me since 2002.
 11. Your advise and opinion on matters in items No. 1 to 10 above.
 12. Inspection and copies from the records of Dl.C.O., AWHO and AWCH Society relating to above information-requests.
 13. Information-disclosures ordered by the SIC vide ,
 - a. Order No. 7739/SIC MVN/2014 dt.9-3-2015
 - b. Order No. 19696/SIC MVN/2015 dt.23-9-2015
 - c. " 32053/SIC MVN/2016 dt. 10-11-2016

The PIO has not furnished the sought information to the complainant.

As the complainant did not receive the sought information from the PIO even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him.

The Complaint was taken on file and notices were issued to the parties concerned for hearing **on 25-04-2022**.

On 25-04-2022 the case is called. The Complainant is absent. The Public Information Officer / Assistant Registrar, O/o the Deputy Registrar of Cooperative Societies, Secunderabad Division, Hyderabad is present.

The Public Information Officer submitted that she has requested to grant (10) days time to enable her to furnish information to the Complainant.

The Complainant did not choose to attend the hearing nor filed affidavit offering his version. The Commission observed that the Complainant is seeking certain records of Army Welfare Housing Society. The similar matter was heard earlier in nearly (30) cases of the Complainant and the Public Information Officer was directed to furnish information to the Complainant on the concise records sought by him.

The Commission directs the Public Information Officer to furnish sought information to the Complainant as assured **within (10) days** by RPAD from the date of receipt of this order and submit compliance to the Commission.

With the above direction, **the Complaint is closed.**
