ORDER

Sri V. RADHAKRISHNA, R/o Hyderabad District filed 2nd appeal dated 15-06-2020 which was received by this Commission on 18-06-2020 for not getting the information sought by him from the PIO / O/o The Deputy Registrar of Co-op Societies, Secunderabad, 5th Floor, Gruhakalpa Building, M.J.Road, Hyderabad and 1st Appellate Authority / O/o The Deputy Registrar of Co-op Societies, Secunderabad, 5th Floor, Gruhakalpa Building, M.J.Road, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 24-01-2020 under Sec.6(1) of the RTI Act, 2005, before the PIO seeking the following information:

Under the circumstances I request you to provide me

1. Copy of the letter as received by your office (from someone not known) under RTI in the matter of reply to the undersigned and others dated 5th November 2019 to which you provided requisite copy as stated by you/ Government pleader in the Hon'ble court on 22nd November 2019
2. Copy of the reply from your office to the applicant (not known) under RTI

The Public Information Officer has not furnished the sought information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1st appeal dated 28-02-2020 before the 1st Appellate Authority requesting him to furnish the information sought.

The First Appellate Authority through notice No. 487/2020-RTI dated 18-03-2020 posted the first appeal for hearing on 26-03-2020.

As the appellant did not get information from the Public Information Officer, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him.

The 2nd Appeal was taken on file and notices were issued to the parties concerned for hearing on 25-04-2022.

On 25-04-2022 the case is called. The appellant is absent. The Public Information Officer / Assistant Registrar, O/o the Deputy Registrar of Cooperative Societies, Secunderabad Division, Hyderabad is present. The 1st Appellate Authority is absent.

The Public Information Officer submitted that she has requested to grant (10) days time to enable her to furnish information to the appellant.

The appellant did not choose to attend the hearing nor filed affidavit offering his version.

The record goes to show that the 6(1) application was filed on 24-01-2020 and no information is furnished by the Public Information Officer so far.

The Commission directs the Public Information Officer to furnish sought information to the appellant as assured **within (10) days** by RPAD from the date of receipt of this order and submit compliance to the Commission.

With the above direction, **the Appeal is closed.**

The Public Information Officer is **warned** to be prompt while dealing with application filed under RTI Act, 2005 and strictly adhere to the stipulated time limits with reference to Sec.7(1) of the RTI Act, 2005.
