ORDER

Sri RAVI KUMAR MAMIDISHETTY, R/o Warangal City & Urban District filed 2nd appeal dated 12-06-2020 which was received by this Commission on 18-06-2020 for not getting the information sought by him from the PIO / O/o the Vice -Chairman, Kakatiya Urban Development Authority(KUDA), Warangal District and 1st Appellate Authority / O/o the Vice -Chairman, Kakatiya Urban Development Authority(KUDA), Warangal District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 11-10-2019 under Sec.6(1) of the RTI Act, 2005, before the PIO seeking the following information:

- 1) Provide Government sanction orders for Formation of 13 KMs Outer Ring Road (Now IRR) from Naidu Petrol Pump to Enumamula (Covering from Urus and Thimmapur Revenue Villages under Fort Warangal and Enumamula Village.
- 2) Provide the Government sanctioned 200' Ring Road Route Alignment Sketch Map (Key Map) with Survey Numbers of 13KMs from Naidu Petrol Pump to Enumamula to know the affected lands with survey numbers in the formation of the road.
- 3) Kindly inform reasons for deviation of Government approved 1971 Warangal Master Plan 200' Road from Keerthi Nagar to behind Railway Track. The KUDA Warangal authorities have deviated the 1KM Government sanctioned 1971 Master Plan 200' Road from Keerthi Nagar to behind Railway Track. Kindly provide Government Order details such deviation.
- 4) Provide the Route Alignment Sketch Map for laying the 200' Ring Road (Now IRR) from Naidu Petrol Pump to Enumamula with survey Numbers which is given by the PIO to P&S Warangal for calling the tenders and formation of Road.
- 5) Provide Orders under what rules the KUDA laying the 200' Road by destructing Minor Irrigation Tank i.e., from the Middle of Kattamallanna Tank, Gorrekunta, Geesugonda Mandal, Warangal Rural. The KUDA authorities proposed 200' IRR in 2041 Warangal Master Plan from the Middle of Kattamallanna Tank, which is against the Government orders issued vide G.O. Ms. No. 168 Municipal Administration and Urban Development, Dated 07-04-2012 read with rules 3 in restricting no building / development shall be allowed within Full Tank Level (FTL) etc.

The Public Information Officer through Letter No. 11837/Plg.II/2019 dated 01-11-2019 transferred the application U/s 6(3) to the Public Information Officer, O/o the Vice -Chairman, Kakatiya Urban Development Authority(KUDA), Warangal District for furnishing the sought information.

The Public Information Officer through letter No. RTI/239/2019 dated 24-10-2019 furnished the sought information to the appellant.

Stating that the information furnished by the Public Information Officer is incomplete / incorrect, the appellant filed 1st appeal dated 02-11-2019 before the 1st Appellate Authority requesting him to furnish the information sought.

As per the records enclosed it is noticed that the 1st Appellate Authority had failed to hear the case and pass appropriate orders on the 1st appeal filed before him.

As the appellant did not get information from the Public Information Officer, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him.

The 2nd Appeal was taken on file and notices were issued to the parties concerned for hearing on **18-04-2022**.

On 18-04-2022 the case is called. The Appellant is absent. The Public Information Officer, O/o the Vice Chairman, Kakatiya Urban Development Authority, KUDA, Hanumakonda is absent. The 1st Appellate Authority is absent.

The record goes to show that the 6(1) application was filed on 11-10-2019 and the Public Information Officer informed the appellant on 24-10-2019 vide letter No.RTI/239/2019 that the sought information relates to Draft Master Plan 2041 which is available in online website i.e. www.kuda.co.in and www.gwmc.gov.in.

The appellant did not choose to attend the hearing nor filed affidavit offering his version. The appellant in his second appeal while admitting to have received information pointed out that the Approved 1971 Master Plan and the unapproved 2041, Draft Warangal Master Plan disappeared in the website. He further alleged that the Public Information Officer is misguiding the Applicant by suppressing the official documents sought by him. Hence he requested the Commission to direct the Public Information Officer to furnish information on the five points mentioned in his 6(1) application.

In view of the above, the Commission directs the Public Information Officer to furnish sought information to the appellant **within (15) days** from the date of receipt of this order and submit compliance to the Commission.

With the above direction, **the Appeal is closed.**

Issue **show cause notice** to Public Information Officer for not attending hearing before the Commission. The action on the show cause notice shall be dealt with separately.
