## **ORDER**

Sri Mohd Azmath Ali, R/o. Hyderabad filed 2<sup>nd</sup> appeal dated 02-05-2019 which was received by this Commission on 04-05-2019 for not getting the information sought by him from the PIO / The Tahsildar, O/o. the Special Deputy Collector, Land Acquisition, GHMC, Hyderabad and 1<sup>st</sup> Appellate Authority / O/o. the Commissioner, Greater Hyderabad Municipal Corporation, Tank Bund Road, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 02-11-2018 under Sec.6(1) of the RTI Act, 2005, before the PIO seeking the following information:

1. Survey No. 182, 182/1, 182/2, 182/3 and 182/4, on the above said survey numbers from Moghal Ka Nala to Garkapalli for road widening how many people's have withdrawn compensation amount firm GHMC for giving the land for road widening, Please provide me the detail with name and address and extent of land ?
2. In each above Survey name how much land acquire for road widening, please give me detail of survey numbers with separate details:

The Public Information Officer has not furnished the sought information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1<sup>st</sup> appeal dated 21-01-2019 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought.

As per the records enclosed it is noticed that the 1<sup>st</sup> Appellate Authority had failed to hear the case and pass appropriate orders on the 1<sup>st</sup> appeal filed before him.

As the appellant did not get information from the Public Information Officer, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to arrange to furnish the information sought by him.

The 2<sup>nd</sup> appeal was taken on file and notices were issued to both the parties for hearing on 06-07-2021.

On 06-07-2021 the case is called. The appellant is present. The PIO / Tahsildar, The Land Acquisition Officer, O/o. the Special Deputy Collector, GHMC, Head Office, Hyderabad is present. The First Appellate Authority / O/o. the Commissioner, Head Office, GHMC, Hyderabad is absent.

The PIO filed affidavit submitting that the 6 (1) application was transferred U/s. 6(3) of RTI Act, 2005 to the Deputy Commissioner, GHMC, Circle-13, Karwan, Hyderabad on 22-05-2019 as there are no records of requisition for acquisition of land for road widening as sought by the appellant. A copy of same was sent to appellant by Speed Post on 22-05-2019. The PIO further submitted that the Deputy Commissioner, GHMC, Circle-13, Karwan has been directed to attend the hearing before the Commission.

The perusal of record shows that the 6 (1) application was filed on 02-11-2018 before the Deputy Commissioner, GHMC, Circle-13, Karwan who transferred the application U/s. 6(3) of RTI Act, 2005 to Special Deputy Collector, Land Acquisition, GHMC, Hyderabad on 09-05-2019 and the same was retransferred on 22-05-2019 U/s. 6(3) of RTI Act, 2005 to the PIO / Deputy Commissioner, GHMC, Circle-13, Karwan to furnish available information to the appellant. The PIO has not furnished any information to the appellant even after (2) years.

The PIO / Deputy Commissioner, GHMC, Circle-13, Karwan is directed to furnish available information to the appellant within (15) days from the date of receipt of this order and submit compliance to the Commission.

The case was adjourned to 27-04-2022.

**On 27-04-2022 the case is called.** The Appellant is present. The Public Information Officer / Deputy Commissioner, Circle-13, Karwan, GHMC, Hyderabad is present. The 1st Appellate Authority is absent.

The case was earlier heard and adjourned on 06-07-2021 with a direction to Public Information Officer / Deputy Commissioner, Circle-13, GHMC, Karwan to attend in person on the next date of hearing with factual information.

The appellant submitted that he has not received information from the Public Information Officer.

The Public Information Officer submitted that the sought information was furnished to the appellant on 22-05-2019 by the Head Office and factual information was furnished by the Public Information Officer on 26-04-2022. The Public Information Officer further submitted that the land is being acquired for road widening which is under process and will be completed in due course of time.

As per directions of the Information Commission the Public Information Officer furnished a copy of information dated 26-04-2022 to the appellant in the presence of the Commission.

Since factual information is furnished, **the Appeal is closed.**
