ORDER

Sri ALLAMPALLI MATHAIAH, R/o Nalgonda District filed 2nd appeal dated 02-07-2020 which was received by this Commission on 07-07-2020 for not getting the information sought by him from the PIO / O/o The Divisional Engineer Electrical(Technical), TSSPDCL, Suryapet, Suryapet District and 1st Appellate Authority / O/o The Superintending Engineer, TSSPDCL, Suryapet, Suryapet District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 17-03-2020 under Sec.6(1) of the RTI Act, 2005, before the PIO seeking the following information:

1. సూర్యాపేట జిల్లా, సూర్యాపేట రూరల్ అసిస్టెంట్ ఇంజనీర్ గా పనిచేస్తున్న వాగిరెడ్డిగారు ఎప్పుడు విధులలో చేరినారు, వారి సాధారణ, సాంకేతిక (టెక్నికల్) విద్యార్హతలు, సర్వీసు పుస్తకము, వారి సర్వీసులో తీసుకున్న పదోన్నతుల వివరాలు, పదోన్నతికి కావాలసిన అర్హతల పూర్తి సర్టిఫికేట్ల సర్టిఫైడ్ జీరాక్స్ ప్రతుల సమగ్ర సమాచారం ఇవ్వగలరు.

ఈ సమాచారం నాకు చేరుతుంది కోరడమైనది.

The Public Information Officer through letter No. Divisional Engineer/T&C Suryapet/R.T.I/D.No.2586/19 dated 31-03-2020 furnished the sought information to the appellant.

Stating that the information furnished by the Public Information Officer is incomplete / incorrect, the appellant filed 1st appeal dated 23-05-2020 before the 1st Appellate Authority requesting him to furnish the information sought.

As per the records enclosed it is noticed that the 1st Appellate Authority had failed to hear the case and pass appropriate orders on the 1st appeal filed before him.

As the appellant did not get information from the Public Information Officer, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him.

The 2nd Appeal was taken on file and notices were issued to the parties concerned for hearing on 10-05-2022.

On 10-05-2022 the case is called. The Appellant is present. The Public Information Officer / Divisional Engineer, Technical, Operation, TSSPDCL, Suryapet is absent. The 1st Appellate Authority is absent.

The Appellant submitted that he did not receive complete information from the Public Information Officer but he did not indicate as to which information is incomplete.

The record goes to show that the 6(1) application was filed on 17-03-2020 and the Public Information Officer has furnished factual information to the appellant on 31-3-2020.

The Commission observed that the Complainant sought 3rd party information without disclosing the larger public interest involved.

Since factual information is furnished, **the Appeal is closed.**

Issue **show cause notice** to Public Information Officer for not attending hearing before the Commission. The action on the show cause notice shall be dealt with separately.
