## ORDER

Sri K.R.RAO, R/o Hyderabad District filed 2<sup>nd</sup> appeal dated 03-07-2020 which was received by this Commission on 09-07-2020 for not getting the information sought by him from the PIO / O/o The Divisional Engineer Operation Medchal, Vennalagadda, Medchal Circle, Jeedimetla(V), Secunderabad and 1<sup>st</sup> Appellate Authority / O/o The Executive Engineer Operation Zonal Office, Quthubullapur Division, Medchal, Malkajgiri District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 30-11-2019 under Sec.6(1) of the RTI Act, 2005, before the PIO seeking the following information:

The Public Information Officer has not furnished the sought information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1<sup>st</sup> appeal dated 19-05-2020 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought.

As per the records enclosed it is noticed that the 1<sup>st</sup> Appellate Authority had failed to hear the case and pass appropriate orders on the 1<sup>st</sup> appeal filed before him.

As the appellant did not get information from the Public Information Officer, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to arrange to furnish the information sought by him.

The 2nd Appeal was taken on file and notices were issued to the parties concerned for hearing **on 10-05-2022**.

**On 10-05-2022** the case is called. The Appellant is present. The Public Information Officer / Assistant Engineer, Technical, Operation, TSSPDCL, Medchal is present. The 1st Appellate Authority is absent.

The Appellant submitted that he did not receive the sought information from the Public Information Officer.

The Public Information Officer submitted that the sought information was furnished to the appellant on 7-01-2020 but he did not produce the dispatch proof.

The Commission directs the Public Information Officer to furnish information dated 7-01-2020 by RPAD to the appellant **within (15) days** from the date of receipt of this order and submit compliance to the Commission.

With the above direction, **the Appeal is closed.**
