ORDER

1. Sri K.R.RAO, R/o Hyderabad District has filed 2nd appeal dated 07-07-2020 which was received by this Commission on 13-07-2020 for not getting the information sought by him from the PIO / O/o The Divisional Engineer Electrical (Operation), TSSPDCL, Jeedimetla Division, Hyderabad and 1st Appellate Authority / O/o The Superintending Engineer, TSSPDCL, Gunrock, Secunderabad-500015.

2. The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 25-11-2019 before the PIO requesting to furnish the information under Sec.6(1) of the RTI Act, 2005, on the following points mentioned in his application:

3. The Public Information Officer has not furnished information to the appellant.
4. Since the appellant did not receive the information from the Public Information Officer, he filed 1st appeal dated 19-05-2020 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.
5. As the appellant did not get the information from the Public Information Officer / 1st Appellate Authority even after (30) days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

The 2nd Appeal was taken on file and notices were issued to the parties concerned for hearing on 14-06-2022.

On 14-06-2022 the case is called. The Appellant is absent. The Public Information Officer / Divisional Engineer, Electrical, TSSPDCL, Jeedimetla, Hyderabad is absent. The 1st Appellate Authority is absent.

The record goes to show that the 6(1) application was filed on 25-11-2019 and the Public Information Officer has not furnished sought information to the appellant so far.

The appellant did not choose to attend the hearing nor filed affidavit offering his version. He sought vast information in his 6(1) application. He is advised to seek specific information in future.

The Commission directs the Public Information Officer to furnish sought information to the appellant **within (15) days** from the date of receipt of this order and submit compliance to the Commission.

With the above direction, **the Appeal is closed.**

Issue **show cause notice** to Public Information Officer for not furnishing the sought information to the appellant within the stipulated time and for not attending hearing before the Commission. The action on the show cause notice shall be dealt with separately.
