## ORDER

Sri V. SRINIVASA CHARY, R/o Karimnagar District filed 2<sup>nd</sup> appeal dated 19-04-2021 which was received by this Commission on 20-04-2021 for not getting the information sought by him from the PIO / O/o The Tahsildar, Thimmapur Mandal, Karimnagar District and 1<sup>st</sup> Appellate Authority / O/o The Revenue Divisional Officer, Collectorate Complex, Karimnagar District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 11-02-2021 under Sec.6(1) of the RTI Act, 2005, before the PIO seeking the following information:

The Public Information Officer through letter No. C/60/2021 dated 25-03-2021 furnished reply to the appellant.

Stating that the information furnished by the Public Information Officer is incomplete / incorrect, the appellant filed 1<sup>st</sup> appeal dated 12-03-2021 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought.

The First Appellate Authority through letter No. K1/1358/2021 dated 25-03-2021 directed the Public Information Officer to furnish the sought information to the appellant within (7) days.

As the appellant did not get information from the Public Information Officer, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to arrange to furnish the information sought by him.

The 2nd Appeal was taken on file and notices were issued to the parties concerned for hearing on **23-05-2022**.

On **23-05-2022** the case is called. The Appellant is absent. The Public Information Officer / Naib Tahsildar, Thimmapur Mandal, Karimnagar District is absent. The Senior Assistant is present on behalf of the Public Information Officer. The 1st Appellate Authority is absent.

The representative of the Public Information Officer submitted that the sought information was furnished to the appellant on 25-03-2021 stating that the sought information is personal information and is exempted as per orders in SLP Civil No.27734/2012.

The appellant did not choose to attend the hearing nor filed affidavit offering his version.

The record goes to show that the appellant in his 6(1) application sought the service book of Sri Sridhar, Revenue Inspector. The Public Information Officer ought to have furnished the service book while leaving the personal data of the individual.

The Commission directs the Public Information Officer to furnish sought information to the appellant as observed above **within (15) days** from the date of receipt of this order and submit compliance to the Commission.

With the above direction, **the Appeal is closed.**
