ORDER

Sri V. SRINIVASA CHARY, R/o Karimnagar District has filed a Complaint dated **19-04-2021** which was received by this Commission on **20-04-2021** for not getting the information sought by him from the PIO / O/o The Tahsildar, Thimmapur Mandal, Karimnagar District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated **12-04-2021** under Sec.6(1) of the RTI Act, 2005, before the PIO seeking following information:

The PIO has not furnished the sought information to the complainant.

As the complainant did not receive the sought information from the PIO even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him.

The Complaint was taken on file and notices were issued to the parties concerned for hearing on **23-05-2022**.

On **23-05-2022** the case is called. The Complainant is absent. The Public Information Officer / Naib Tahsildar, Thimmapur Mandal, Karimnagar District is absent. The Senior Assistant is present on behalf of the Public Information Officer.

The representative of the Public Information Officer submitted that the sought information was furnished to the Complainant on 20-5-2022 vide letter No.C/173/2021.

The Complainant did not choose to attend the hearing nor filed affidavit offering his version.

The record goes to show that Complainant in his the 6(1) application sought the name of the Tahsildar who made irregular entry in Dharani Agriculture Portal on some other name in respect of survey number 446/D despite of pending appeal before the RDO whereas the Public Information Officer sought file number in his reply which is absurd as irrelevant information.

The Commission directs the Public Information Officer to furnish the name of the Tahsildar who made irregular entry in Dharani Portal to the appellant **within (15) days** from the date of receipt of this order and submit compliance to the Commission.

With the above direction, **the Complaint is closed.**
