ORDER

Sri V. SRINIVASA CHARY, R/o Karimnagar District filed 2nd appeal dated 19-04-2021 which was received by this Commission on 20-04-2021 for not getting the information sought by him from the PIO / O/o The Tahsildar, Thimmapur Mandal, Karimnagar District and 1st Appellate Authority / O/o The Revenue Divisional Officer, Collectorate Complex, Karimnagar District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 30-01-2021 under Sec.6(1) of the RTI Act, 2005, before the PIO seeking the following information:

The Public Information Officer has not furnished the sought information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1st appeal dated 01-03-2021 before the 1st Appellate Authority requesting him to furnish the information sought.

The First Appellate Authority through letter No. K1/1338/2021 dated 24-03-2021 directed the Public Information Officer to furnish the sought information to the appellant within (7) days.

As the appellant did not get information from the Public Information Officer, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him.

The 2nd Appeal was taken on file and notices were issued to the parties concerned for hearing on **23-05-2022**.

On **23-05-2022** the case is called. The Appellant is absent. The Public Information Officer / Naib Tahsildar, Thimmapur Mandal, Karimnagar District is absent. The Senior Assistant is present on behalf of the Public Information Officer. The 1st Appellate Authority is absent.

The representative of the Public Information Officer submitted that the sought information was furnished to the appellant on 27-03-2021 by speed post vide letter No.C/41/2021 seeking sada bainama file number from the appellant.

The appellant did not choose to attend the hearing nor filed affidavit offering his version.

The appellant is advised to indicate the file number as sought by the Public Information Officer, so as to enable him to permit for inspection of connected records as desired.

With the above observation, **the Appeal is closed.**
