ORDER

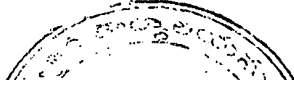
Sri V. SRINIVASA CHARY, R/o Karimnagar District filed 2nd appeal dated 19-04-2021 which was received by this Commission on 20-04-2021 for not getting the information sought by him from the PIO / O/o The Tahsildar, Thimmapur Mandal, Karimnagar District and 1st Appellate Authority / O/o The Revenue Divisional Officer, Collectorate Complex, Karimnagar District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 22-09-2020 under Sec.6(1) of the RTI Act, 2005, before the PIO seeking the following information:

Respected Sir

The RDO Karimnagar issued Lr No A/03/2020 dt 04/01/2020 to Tahsildar Thimmapur and directed to submit the detailed report along with the proper enclosures for taking further necessary actions against A Sri Shaibam Village revenue officer Agunoor.

Therefore I request you please supply action taken report as per the RDO Karimnagar order with certified



The Public Information Officer through letter No. B/1238/2020 dated 10-12-2020 furnished the sought information to the appellant.

Stating that the information furnished by the Public Information Officer is incomplete / incorrect, the appellant filed 1st appeal dated 09-11-2020 before the 1st Appellate Authority requesting him to furnish the information sought.

As per the records enclosed it is noticed that the 1st Appellate Authority had failed to hear the case and pass appropriate orders on the 1st appeal filed before him.

As the appellant did not get information from the Public Information Officer, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him.

The 2nd Appeal was taken on file and notices were issued to the parties concerned for hearing on **23-05-2022**.

On 23-05-2022 the case is called. The Appellant is absent. The Public Information Officer / Naib Tahsildar, Thimmapur Mandal, Karimnagar District is absent. The Senior Assistant is present on behalf of the Public Information Officer. The 1st Appellate Authority is absent.

The representative of the Public Information Officer submitted that the sought information was furnished to the appellant on 10-12-2020 by speed post.

The appellant did not choose to attend the hearing nor filed affidavit offering his version.

Since information is furnished, **the Appeal is closed.**
