ORDER

Smt MAHEELATHA, R/o Secunderabad has filed a Complaint dated 20-07-2020 which was received by this Commission on 23-07-2020 for not getting the information sought by her from the PIO / O/o The Divisional Co-op Officer, Vth Floor, Gruhakalpa, M.J.Road, Hyderabad.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated 06-07-2019 under Sec.6(1) of the RTI Act, 2005, before the PIO seeking following information:

1. Information as cited above (in certified copies).

1. Entire correspondence on the stated subject between the Society and your office/department (between 2015 - 2017)
2. The rules/laws and procedures under which the cited correspondence was resorted to, and allowed by the RCS
3. In case of any matter was in dispute (on the stated subject)
 - (a) whether matter was referred to the managing committee and General Body
 - (b) whether matter was referred to the Supervisory council, or
 - (c) whether a reference of the dispute/controversy was made to the Registrar u/s 62
4. Whether (a) any inquiry was conducted for fact-finding, (b) If so, the relevant fact-finding, records, evidence and witnesses
5. Compliance-record of due processes and natural justice
6. Copy of preliminary and final findings/report
7. Status/disposal/action-taken-report on the allegations made by the office-bearers of Society through the correspondence on the stated subject (against Ranga Reddy and V S Reddy)
8. The objects and activities of the Society as permitted by the RCS
9. The Certificate-of-Registration issued by RCS u/s 8 to Society
10. Compliance-record u/r 58 by the RCS in respect of Society

The PIO has not furnished the sought information to the complainant.

As the complainant did not receive the sought information from the PIO even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him.

The Complaint was taken on file and notices were issued to the parties concerned for hearing on 25-04-2022.

On 25-04-2022 the case is called. The Complainant is absent. The Public Information Officer / Assistant Registrar, O/o the Deputy Registrar of Cooperative Societies, Secunderabad Division, Hyderabad is present.

The Public Information Officer submitted that she has requested to grant (10) days time to enable her to furnish information to the Complainant.

The Complainant did not choose to attend the hearing nor filed affidavit offering his version.

The record goes to show that the 6(1) application was filed on 06-07-2019 and no information is furnished by the Public Information Officer so far.

The Commission directs the Public Information Officer to furnish sought information to the Complainant as assured **within (10) days** by RPAD from the date of receipt of this order and submit compliance to the Commission.

With the above direction, **the Complaint is closed.**

The Public Information Officer is **warned** to be prompt while dealing with application filed under RTI Act, 2005 and strictly adhere to the stipulated time limits with reference to Sec.7(1) of the RTI Act, 2005.
