ORDER

Sri M. MADHAVA REDDY, R/o Hyderabad District filed 2nd appeal dated 27-07-2020 which was received by this Commission on 03-08-2020 for not getting the information sought by him from the PIO / O/o The Deputy Registrar of Cooperative Housing Societies, 5th Floor, Gruhakalpa, M.J.Road, Hyderabad and 1st Appellate Authority / O/o The Deputy Registrar of Cooperative Housing Societies, 5th Floor, Gruhakalpa, M.J.Road, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 11-03-2020 under Sec.6(1) of the RTI Act, 2005, before the PIO seeking the following information:

- Furnish me the following information under R.T.I. Act.*
- ① Whether still the Karatiga Co-operative Housing Society Ltd T.A.116 is still functioning or it is de-functional. (Not Functioning)
 - ② If the said society is functioning are they conducting Executive meetings and General Body meetings and intimating to the Deputy Registrar time to time.
 - ③ As per your Records when was the last meeting of the E.C and General Body was conducted by the society and intimated to you.
 - ④ As per your Records when was the Elections to the said society was conducted and by whom? who was the officer from co-operative department conducted the Election to the Managing Committee of the society.
 - ⑤ As per your Records who is the ^{present} Managing Committee of the Society.
 - ⑥ As per your Records any Audit is conducted on the day today transactions of the society.

Kindly furnish me the above said information under R.T.I. Act as some of the vested interested persons, keeping the society records with them playing fraud with the genuine members of the society for their selfish interests of no activities by the society.

The Public Information Officer through Letter No. 72/2020-RTI dated 20-06-2020 transferred the application U/s 6(3) to the Public Information Officer, O/o The Deputy Registrar of Cooperative Housing Societies, 5th Floor, Gruhakalpa, M.J.Road, Hyderabad for furnishing the sought information.

The Public Information Officer has not furnished the sought information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1st appeal dated 09-06-2020 before the 1st Appellate Authority requesting him to furnish the information sought.

As per the records enclosed it is noticed that the 1st Appellate Authority had failed to hear the case and pass appropriate orders on the 1st appeal filed before him.

As the appellant did not get information from the Public Information Officer, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him.

The 2nd Appeal was taken on file and notices were issued to the parties concerned for hearing on **25-04-2022**.

On **25-04-2022** the case is called. The Appellant is present. The Public Information Officer / Assistant Registrar, O/o the Deputy Registrar of Cooperative Societies, Secunderabad Division, Hyderabad is present. The 1st Appellate Authority is absent.

The Appellant submitted that he did not receive the sought information from the Public Information Officer.

The Public Information Officer submitted that she has requested to grant (10) days time to enable her to furnish information to the appellant.

The record goes to show that the 6(1) application was filed on 11-03-2020 and no information is furnished by the Public Information Officer so far.

The Commission directs the Public Information Officer to furnish sought information to the appellant as assured **within (10) days** by RPAD from the date of receipt of this order and submit compliance to the Commission.

With the above direction, **the Appeal is closed.**

The Public Information Officer is **warned** to be prompt while dealing with application filed under RTI Act, 2005 and strictly adhere to the stipulated time limits with reference to Sec.7(1) of the RTI Act, 2005.
