## ORDER

Sri Pallela Devaraju, R/o Karimnagar District filed 2<sup>nd</sup> appeal dated 19-05-2021 which was received by this Commission on 25-05-2021 for not getting the information sought by him from the PIO / 1) O/o The District Collector, Karimnagar District-505001 2) O/o The Varadhi Society, Karimnagar District-505001 and 1<sup>st</sup> Appellate Authority / O/o The District Collector, Karimnagar District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 10-03-2021 under Sec.6(1) of the RTI Act, 2005, before the PIO seeking the following information:

The Public Information Officer through Letter No. H2/251/2021 dated 20-03-2021 transferred the application U/s 6(3) to the Public Information Officer, 1)O/o The District Collector, Karimnagar District-505001 2)O/o The Varadhi Society, Karimnagar District-505001 for furnishing the sought information.

The Public Information Officer has not furnished the sought information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1<sup>st</sup> appeal dated 12-04-2021 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought.

The First Appellate Authority through notice No. H2/327/2021 dated 29-04-2021 posted the first appeal for hearing on 04-05-2021.

As the appellant did not get information from the Public Information Officer, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to arrange to furnish the information sought by him.

The 2nd Appeal was taken on file and notices were issued to the parties concerned for hearing on **17-05-2022**.

**On 17-05-2022** the case is called. The Appellant is absent. The Public Information Officer-I, O/o the District Collector, Karimnagar District is absent. The Naib Tahsildar, Kothapally Mandal is present on behalf of the Public Information Officer. The Public Information Officer-II, O/o the Varadhi Society, Karimnagar is present. The 1st Appellate Authority is absent.

The representative of the Public Information Officer submitted that the sought information was furnished to the appellant on 20-04-2021 by the Member Secretary, Varadhi Society, Karimnagar. The Public Information Officer produced copy of information furnished along with dispatch proof.

The appellant did not choose to attend the hearing nor filed affidavit offering his version.

Since factual information is furnished, **the Appeal is closed.**

Issue **show cause notice** to Public Information Officer for not attending hearing before the Commission. The action on the show cause notice shall be dealt with separately.
