ORDER

Smt SARITHA GUNDU, R/o Mulugu District filed 2nd appeal dated 24-08-2020 which was received by this Commission on 25-08-2020 for not getting the information sought by her from the PIO / O/o The Greater Warangal Municipal Corporation, Beside MGM Hospital, Warangal District and 1st Appellate Authority / O/o The Greater Warangal Municipal Corporation, Beside MGM Hospital, Warangal District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 27-06-2020 under Sec.6(1) of the RTI Act, 2005, before the PIO seeking the following information:

The Public Information Officer has not furnished the sought information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1st appeal dated 31-07-2020 before the 1st Appellate Authority requesting him to furnish the information sought.

As per the records enclosed it is noticed that the 1st Appellate Authority had failed to hear the case and pass appropriate orders on the 1st appeal filed before him.

As the appellant did not get information from the Public Information Officer, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him.

The 2nd Appeal was taken on file and notices were issued to the parties concerned for hearing **on 18-04-2022**.

On 18-04-2022 the case is called. The Appellant is present. The Public Information Officer, O/o the Municipal Commissioner, GWMC, Warangal is present. The 1st Appellate Authority is absent.

The Appellant submitted that she did not receive the documents i.e. death certificate, legal heir certificate etc. submitted for change of name.

The Public Information Officer submitted that the sought information was furnished to the appellant on 24-08-2021.

The Commission directs the Public Information Officer to furnish the documents sought by the appellant in complete shape **within (15) days** from the date of receipt of this order and submit compliance to the Commission.

With the above direction, **the Appeal is adjourned** for compliance by the Public Information Officer.
