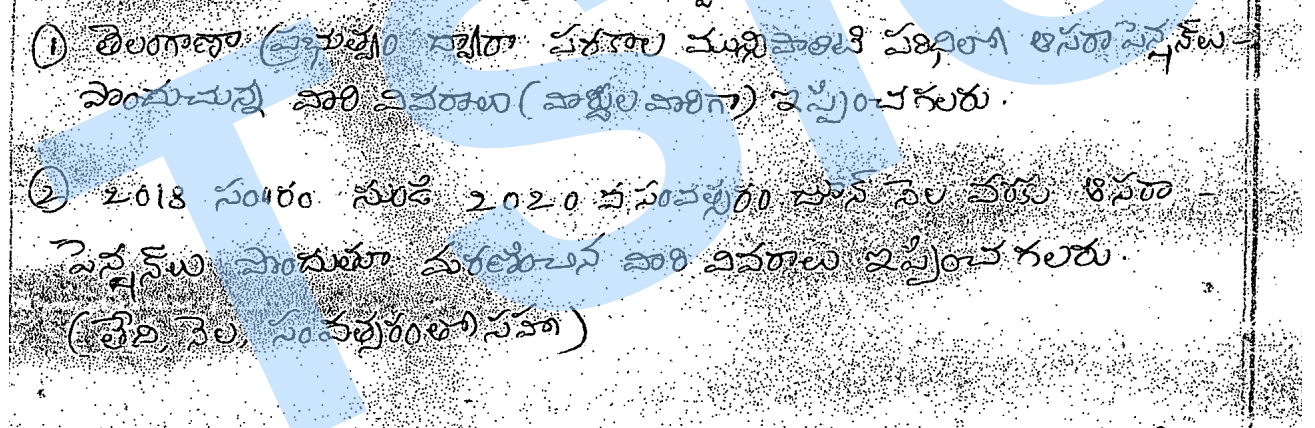

## **ORDER**

Sri VENKATESHWARLU KESHETTI, R/o Warangal Rural District filed 2<sup>nd</sup> appeal dated 24-08-2020 which was received by this Commission on 27-08-2020 for not getting the information sought by him from the PIO / O/o The Municipal Commissioner, Parakal Municipality, Warangal Rural District and 1<sup>st</sup> Appellate Authority / O/o The District Collector, Warangal Rural District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 29-06-2020 under Sec.6(1) of the RTI Act, 2005, before the PIO seeking the following information:



The Public Information Officer has not furnished the sought information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1<sup>st</sup> appeal dated 31-07-2020 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought.

As per the records enclosed it is noticed that the 1<sup>st</sup> Appellate Authority had failed to hear the case and pass appropriate orders on the 1<sup>st</sup> appeal filed before him.

As the appellant did not get information from the Public Information Officer, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to arrange to furnish the information sought by him.

The 2<sup>nd</sup> Appeal was taken on file and notices were issued to the parties concerned for hearing on 18-04-2022.

On 18-04-2022 the case is called. The Appellant is absent. The Public Information Officer, O/o the Municipal Commissioner, Parakala, Warangal Rural District is absent. The Revenue Officer is present on behalf of the Public Information Officer. The 1<sup>st</sup> Appellate Authority is absent.

The representative of the Public Information Officer submitted that part information was furnished to the appellant on 27-08-2020 and complete information consisting of (78) pages was furnished to the appellant on 26-09-2020 duly acknowledged by the appellant in person. The Public Information Officer produced copy of acknowledgment of the appellant.

The appellant did not choose to attend the hearing nor filed affidavit offering his version.

Since information is furnished, **the Appeal is closed.**
