ORDER

1. Sri K. NARASIMHA, R/o.H.No.2-18, Swamivari Lingotam Village, Nampally Mandal, Nalgonda Dist-508201.has filed 2nd appeal dated 25-08-2020 which was received by this Commission on 27-08-2020 for not getting the information sought by him from the PIO / O/o The District Agriculture Officer, Nalgonda District-508001 and 1st Appellate Authority / O/o The District Collector, Nalgonda District-508001.

2. The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 15-06-2020 before the PIO requesting to furnish the information under Sec.6(1) of the RTI Act, 2005, on the following points mentioned in his application:

3. The Public Information Officer has not furnished information to the appellant.

4. Since the appellant did not receive the information from the Public Information Officer, he filed 1st appeal dated 13-07-2020 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

5. As the appellant did not get the information from the Public Information Officer / 1st Appellate Authority even after (30) days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

The 2nd Appeal was taken on file and notices were issued to the parties concerned for hearing on 13-06-2022.

On 13-06-2022 the case is called. The Appellant is present after hearing of the case. The Public Information Officer / Administrative Officer, O/o the District Agriculture Officer, Nalgonda is present. The 1st Appellate Authority is absent.

The Appellant submitted that he did not receive the sought information from the Public Information Officer.

The Public Information Officer submitted that the sought information was furnished to the appellant on 9-6-2022 but he did not produce the dispatch proof.

The Commission directs the Public Information Officer to furnish sought information once again to the appellant by RPAD within (15) days from the date of receipt of this order and submit compliance to the Commission.

The Commission took a serious view in the delay of furnishing information and directs the Public Information Officer to be more careful in future while dealing with the applications filed under RTI Act, 2005.

With the above direction, **the Appeal is closed.**
