## **ORDER**

Sri MIR TAUSEEF ALI, R/o Hyderabad District filed 2<sup>nd</sup> appeal dated 25-08-2020 which was received by this Commission on 28-08-2020 for not getting the information sought by him from the PIO / O/o The Zonal Commissioner, GHMC, Central Zone, Khairtabad, Hyderabad and 1<sup>st</sup> Appellate Authority / O/o The Commissioner, GHMC, CC Complex Tank Bund Road, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 17-06-2020 under Sec.6(1) of the RTI Act, 2005, before the PIO seeking the following information:

- I. As per section 6(3)(i),(ii)and(iii) of the RTI Act 2005, In case, the requested information is held by another public authority , I request the PIO to transfer the application or part of it within FIVE day and immediately inform me about such transfer.
- II. As per section 7(3) and 7(3)(A) of the RTI Act 2005, In case, there are further fee required to provide the requested information, I request the PIO to inform me of the additional fee amount along with the calculations made to arrive at the amount.
- III. To best of my knowledge, the above desired information does not relate to section 9 of the RTI Act 2005, which are exempted from disclosure.
- IV. Right to information Act 2005 Fees of Rs.10/- is paid and attached in the form of Court fee Stamps with this Application.
- V. The information I have requested can be given within the prescribed duration as per the Right to Information Act, 2005.

The Public Information Officer has not furnished the sought information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1<sup>st</sup> appeal dated 21-07-2020 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought.

As per the records enclosed it is noticed that the 1<sup>st</sup> Appellate Authority had failed to hear the case and pass appropriate orders on the 1<sup>st</sup> appeal filed before him.

As the appellant did not get information from the Public Information Officer, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to arrange to furnish the information sought by him.

The 2nd Appeal was taken on file and notices were issued to the parties concerned for hearing on **20-04-2022**.

**On 20-04-2022** the case is called. The Appellant is absent. The Public Information Officer / Zonal Commissioner, Khairathabad Zone, GHMC, Hyderabad is absent. The Assistant Municipal Commissioner is present on behalf of the Public Information Officer. The 1st Appellate Authority is absent.

The representative of the Public Information Officer submitted that the information is ready and is being sent to the appellant.

The appellant did not choose to attend the hearing nor filed affidavit offering his version.

The record goes to show that the 6(1) application was filed on 17-06-2020 and the information is being furnished by the Public Information Officer with delay of nearly two years.

The Commission directs the Public Information Officer to furnish sought information to the appellant **within (10) days** from the date of receipt of this order and submit compliance to the Commission.

With the above direction, **the Appeal is closed.**

The Public Information Officer is **warned** to be prompt while dealing with application filed under RTI Act, 2005 and strictly adhere to the stipulated time limits with reference to Sec.7(1) of the RTI Act, 2005.
