ORDER

1. Sri B. SRAVYA, H.No.7-7-187/3/F, Mahalaxmi Nagar, Jagitial - 505 327.has filed a Complaint dated 25-8-2020 which was received by this Commission on 28-8-2020 for not getting the information sought by him from the PIO / O/o The Telangana State Co-operative Apex Bank Limited, Troop Bazar, Hyderabad-500001.

2. The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated 12-8-2020 before the PIO requesting to furnish the information under Sec.6(1) of the RTI Act, 2005, on the following points mentioned in his application.

1) Telangana State Co-operative Apex Bank Limited (Govt partnered Scheduled Bank) వారు జారీచేసిన Notification dated: 09/08/2019 లో పేర్కొనబడిన RBI Letter dated: 04/01/2018 యొక్క copy RTI act-2005 ప్రకారం కృపాకరించి ఇవ్వగలను.

2) NABARD No.NB.IDD.COOP/1351/V-52/2017-18, 17 January 2018 Circular NO.13/IDD-01/2018 కి RCS సుండ్ల, State పుస్తకీ వచ్చిన approval కుండా RTI act-2005 ప్రకారం కృపాకరించి ఇవ్వగలను.

ఈ సమాచారాన్ని RTI act -2005 ప్రకారం కృపాకరించి సంతృప్తిగా ఇవ్వగలను.

3. The Public Information Officer has not furnished information to the Complainant.

4. As the Complainant did not receive the required information from the PIO even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

The Complaint was taken on file and notices were issued to the parties concerned for hearing on **13-06-2022**.

On **13-06-2022** the case is called. The Complainant is absent. The Public Information Officer / Deputy General Manager, O/o the T.S.Cooperative Apex Bank, Abids, Hyderabad is present.

The Public Information Officer submitted that the T.S.Cooperative Apex Bank Ltd., does not come under Sec.2(h) of RTI Act, 2005. The Public Information Officer has produced a copy of the orders passed by the Information Commission earlier in Complaint No.8276/SIC-Dr.Mohd.Ameer/2019 dated 01-11-2021 wherein the Commission observed that the Bank do not fall under Sec.2(h) of RTI Act 2005.

As per the provisions of RTI Act 2005 the burden of proving whether the office falls under Public Authority or not lies on the Complainant. In the instant case the Complainant did not choose to attend the hearing nor filed affidavit offering his version.

In view of the above, **the Complaint is closed.**
