ORDER

Sri SAGAR KOMPALLI, R/o Karimnagar District has filed a Complaint dated 28-08-2020 which was received by this Commission on 01-09-2020 for not getting the information sought by him from the PIO / O/o The Commissioner, Karimnagar Municipal Corporation, Karimnagar District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated 04-06-2020 under Sec.6(1) of the RTI Act, 2005, before the PIO seeking following information:

The PIO has not furnished the sought information to the complainant.

As the complainant did not receive the sought information from the PIO even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him.

The Complaint was taken on file and notices were issued to the parties concerned for hearing on 09-05-2022.

On 09-05-2022 the case is called. The Complainant is absent. The Public Information Officer, O/o the Municipal Commissioner, Karimnagar Municipal Corporation, Karimnagar is present.

The Public Information Officer submitted that the sought information was furnished to the Complainant on 19-08-2020 through courier.

The Complainant did not choose to attend the hearing nor filed affidavit offering his version.

The Commission observed that the information was furnished by the Public Information Officer through courier which is against the provisions of RTI Act 2005. He ought to have furnished the information by RPAD.

Therefore, the Commission directs the Public Information Officer to furnish information once again to the appellant by RPAD **within (15) days** from the date of receipt of this order and submit compliance to the Commission.

With the above direction, **the Complaint is closed.**
