ORDER

Sri SAGAR KOMPALLI, R/o Karimnagar District has filed a Complaint dated 28-08-2020 which was received by this Commission on 01-09-2020 for not getting the information sought by him from the PIO / O/o The Commissioner, Karimnagar Municipal Corporation, Karimnagar District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated 19-04-2020 under Sec.6(1) of the RTI Act, 2005, before the PIO seeking following information:

The PIO has not furnished the sought information to the complainant.

As the complainant did not receive the sought information from the PIO even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him.

The Complaint was taken on file and notices were issued to the parties concerned for hearing on 09-05-2022.

On 09-05-2022 the case is called. The Complainant is absent. The Public Information Officer, O/o the Municipal Commissioner, Karimnagar Municipal Corporation, Karimnagar is present.

The Public Information Officer submitted that the Complainant was informed on 10-12-2020 vide letter No.G2/43/RTI/2020 to obtain the information by visiting their office on any working day during the office hours.

The Public Information Officer further submitted during the hearing that the Complainant sought the details of land acquired for construction of Helipad at Teegalaguttapally village. The Public Information Officer further submitted that the proposal of land acquisition for construction of Helipad were withdrawn vide notification dated 1-6-2019. He has produced a copy of notice along with letter of the District Collector in the matter.

The Complainant did not choose to attend the hearing nor filed affidavit offering his version.

The Commission directs the Public Information Officer to furnish the above factual information to the Complainant **within (15) days** from the date of receipt of this order and submit compliance to the Commission.

With the above direction, **the Complaint is closed.**
