The PIO has not furnished the sought information to the complainant.

As the complainant did not receive the sought information from the PIO even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him.

The Complaint was taken on file and notices were issued to the parties concerned for hearing on 09-05-2022.

On 09-05-2022 the case is called. The Complainant is absent. The Public Information Officer, O/o the Municipal Commissioner, Karimnagar Municipal Corporation, Karimnagar is present.

The Public Information Officer submitted that the Complainant was informed on 20-04-2021 to inspect the records on 27-04-2021 during office hours and take over the available records. The Complainant did not turn up and hence the information could not be furnished.

The Complainant did not choose to attend the hearing nor filed affidavit offering his version.

The Complainant is advised to inspect the records as suggested by the Public Information Officer and take out the required information on payment of cost, if he still desires the information.

With the above direction, **the Complaint is closed.**

The Public Information Officer is cautioned to be prompt while dealing with application filed under RTI Act, 2005 and strictly adhere to the stipulated time limits with reference to Sec.7(1) of the RTI Act, 2005.
