## **ORDER**

1. Sri KOLLU RAVINDRABABU, Plot No.239-A, HIG Phase II, Ushodaya Enclave, Madeenaguda, Hyd - 500 049 has filed 2<sup>nd</sup> appeal dated 31-8-2020 which was received by this Commission on 2-9-2020 for not getting the information sought by him from the PIO / O/o The Commissioner and Director of Agriculture, Telangana State, Ground Floor, D-block, Fathe Midan, Basheer Bagh, Near Nizam College, Basheer Bagh, Hyderabad-500001 and 1<sup>st</sup> Appellate Authority / O/o The Commissioner and Director of Agriculture, Telangana State, Ground Floor, D-block, Fathe Midan, Basheer Bagh, Near Nizam College, Basheer Bagh, Hyderabad-500001.
2. The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 25-6-2020 before the PIO requesting to furnish the information under Sec.6(1) of the RTI Act, 2005, on the following points mentioned in his application:

Dear Sir,  
I am having an agricultural land of Ac.9.39 Gts in Sy No. 573/4, 573/5, 576/1, 576/2 & 577/18. Situated in Ananthagiri Village and Mandal, Suryapet District and Ac.1.00 Gts agricultural land situated in Sy.No. 543/2 and 544/2, Situated in Chilkuru Village and Mandal, Suryapeta District. My brother Kollu Durga Prasad is having an agriculture land of Ac.12.17 Gts: situated in Sy.No. 543/1, 549/5a, 549/5b, 549/5c, 549/6, 549/6/1, 550/2, 550/3, 550/4, 550/5, 550/6, 543/3, 550/3, 543/8, 544/1, 544/2, 544/3, 544/4, 544/5, 544/6, 544/7, 544/8, 544/9, 544/10, 544/11, 544/12, 544/13, 544/14, 544/15, 544/16, 544/17, 544/18, 544/19, 544/20, 544/21, 544/22, 544/23, 544/24, 544/25, 544/26, 544/27, 544/28, 544/29, 544/30, 544/31, 544/32, 544/33, 544/34, 544/35, 544/36, 544/37, 544/38, 544/39, 544/40, 544/41, 544/42, 544/43, 544/44, 544/45, 544/46, 544/47, 544/48, 544/49, 544/50, 544/51, 544/52, 544/53, 544/54, 544/55, 544/56, 544/57, 544/58, 544/59, 544/60, 544/61, 544/62, 544/63, 544/64, 544/65, 544/66, 544/67, 544/68, 544/69, 544/70, 544/71, 544/72, 544/73, 544/74, 544/75, 544/76, 544/77, 544/78, 544/79, 544/80, 544/81, 544/82, 544/83, 544/84, 544/85, 544/86, 544/87, 544/88, 544/89, 544/90, 544/91, 544/92, 544/93, 544/94, 544/95, 544/96, 544/97, 544/98, 544/99, 544/100. Situated in Chilkuru Village and Mandal, Suryapeta District. We both have got Rythubandu amount for Kharif and Rabi in 2018, Kharif in 2019 and Now Kharif(Vanakalam) 2020. But we both did not get Rythubandu for Rabi in 2019. I asked DAO Suryapet District the same over phone. DAO told me that DAO did not have any information regarding this. Hence I request you to provide me information for the following points under RTI Act-2005.  
1. Please let me know the reason for paying rythu bandu for Rabi 2019 to part of the farmers and not paying to all the farmers in the state.  
2. Please let me know the reason for not paying rythu bandu for Rabi 2019 to both of us. When would we get the Rythubandu for Rabi in 2019.
3. The Public Information Officer has not furnished information to the appellant.
4. Since the appellant did not receive the information from the Public Information Officer, he filed 1<sup>st</sup> appeal dated 20-7-2020 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.
5. As the appellant did not get the information from the Public Information Officer / 1<sup>st</sup> Appellate Authority even after (30) days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

The 2nd Appeal was taken on file and notices were issued to the parties concerned for hearing on **13-06-2022**.

**On 13-06-2022** the case is called. The Appellant is absent. The Public Information Officer / Deputy Director of Agriculture, O/o the Commissioner of Agriculture, Hyderabad is present. The 1st Appellate Authority is absent.

The Public Information Officer submitted that the sought information was furnished to the appellant vide letter No.RTI/3/181/2020 dated 14-07-2020. She has produced copy of information furnished along with proof of dispatch.

The appellant did not choose to attend the hearing nor filed affidavit offering his version.

Since information is furnished, **the Appeal is closed.**
