ORDER

Sri Ghansham Ojha, R/o Karimnagar District has filed a Complaint dated **05-09-2020** which was received by this Commission on **08-09-2020** for not getting the information sought by him from the PIO / O/o The Commissioner, Karimnagar Municipal Corporation, Karimnagar District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated **12-03-2020** under Sec.6(1) of the RTI Act, 2005, before the PIO seeking following information:

Sub: Requisition under RTI ACT-2005 to provide me the detailed information about Traffic Circle Junctions Beautification cost for construction, private contractor full details whom work allotted by Municipal Corporation Authority Karimnagar in Town-Karimnagar, Telangana State, India since last 3-Years, regarding.

With subject cited above I wish to bring to your kind notice that I am seeking the detailed information about "Traffic Circle Junctions Beautification in Town Karimnagar" cost of construction, private contractor full details whom the work allotted by Municipal Corporation Authority Karimnagar in Town-Karimnagar, Telangana State. I also request you to provide me the details of funds sanctioned and approved for "Traffic Circle Junctions Beautification in Town Karimnagar" by Municipal Corporation Authority Karimnagar in last 8-Years from 2012 to 2020 ! **Traffic Circle Junctions names: 1) Kaman Circle 2) Bus Stand in Gate Circle Opp: ZP office 3) Indira Chowk #Geeth Bhavan Hotel Circle 4) IB Guest House 5) Court Circle 6) Civil Hospital Road Circle 7) Naka Chowrasta 8) Mangalayam Shopping Mall Circle 9) Tower Circle 10) Softy Point Ice Shop Circle.**

Along with this requisition mail I am paying RTI Act-2005 fee in the form of Indian Postal Order bearing Number: **39F537221** and I request you to answer for my raised questions under Right To Information Act-2005 and kindly acknowledge the receipt to the same immediately and do needful in the matter!

Waiting for your most immediate concern sir !

The PIO has not furnished the sought information to the complainant.

As the complainant did not receive the sought information from the PIO even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him.

The Complaint was taken on file and notices were issued to the parties concerned for hearing on **09-05-2022**.

On **09-05-2022** the case is called. The Complainant is present. The Public Information Officer, O/o the Municipal Commissioner, Karimnagar Municipal Corporation, Karimnagar is present.

The Complainant submitted that he did not receive the sought information from the Public Information Officer so far.

The Public Information Officer submitted that the factual information point wise was sent to the Complainant on 10-9-2020 through courier.

As per directions of the Information Commission the Public Information Officer furnished a copy of information dated 10-9-2020 to the Complainant in the presence of the Commission.

The Public Information Officer is cautioned to send the information under RTI Act 2005 by RPAD only in future.

Since information is furnished, **the Complaint is closed.**
