ORDER

1. Sri N. SANDEEP PRAKASH, H.No.13-3-1049/48, Near Nsllapochamma Temple, Indiranagar, Jiyaguda, Hyderabad District-500006 has filed 2nd appeal dated 8-9-2020 which was received by this Commission on 9-9-2020 for not getting the information sought by him from the PIO / O/o The District Agriculture Officer, Ranga Reddy District-501401 and 1st Appellate Authority / O/o The Commissioner & Director of Agriculture, Hyderabad-500001.

2. The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 17-6-2020 before the PIO requesting to furnish the information under Sec.6(1) of the RTI Act, 2005, on the following points mentioned in his application:

3. The Public Information Officer has not furnished information to the appellant.
4. Since the appellant did not receive the information from the Public Information Officer, he filed 1st appeal dated 10-8-2020 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.
5. As the appellant did not get the information from the Public Information Officer / 1st Appellate Authority even after (30) days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

The 2nd Appeal was taken on file and notices were issued to the parties concerned for hearing on **13-06-2022**.

On **13-06-2022** the case is called. The Appellant is absent. The Public Information Officer / Deputy Director of Agriculture, O/o the Commissioner of Agriculture, Hyderabad is present. The 1st Appellate Authority is absent.

The Public Information Officer submitted that the sought information was furnished to the appellant vide letter No.RTI/3/159/2020 dated 22-06-2020. She has produced copy of information furnished along with proof of dispatch.

The appellant did not choose to attend the hearing nor filed affidavit offering his version.

Since information is furnished, **the Appeal is closed.**
