ORDER

Sri CHANDRAIAH BURRA, R/o Bhupalapalli District filed 2nd appeal dated 14-09-2020 which was received by this Commission on 16-09-2020 for not getting the information sought by him from the PIO / O/o The Bhupalapalli Municipality, Bhupalapalli Mandal, Bhupalapalli District and 1st Appellate Authority / O/o The Bhupalapalli Municipality, Bhupalapalli Mandal, Bhupalapalli District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 23-06-2020 under Sec.6(1) of the RTI Act, 2005, before the PIO seeking the following information:

The Public Information Officer has not furnished the sought information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1st appeal dated 10-08-2020 before the 1st Appellate Authority requesting him to furnish the information sought.

As per the records enclosed it is noticed that the 1st Appellate Authority had failed to hear the case and pass appropriate orders on the 1st appeal filed before him.

As the appellant did not get information from the Public Information Officer, he preferred this 2nd appeal before this Commission requesting to arrange to furnish the information sought by him.

The 2nd Appeal was taken on file and notices were issued to the parties concerned for hearing on **24-05-2022**.

On **24-05-2022** the case is called. The Appellant is absent. The Public Information Officer, O/o the Municipal Commissioner, Bhupalapally Municipality, Bhupalapally District is absent. The 1st Appellate Authority is absent.

The record goes to show that the 6(1) application was filed on 23-6-2020 and the Public Information Officer has not furnished sought information to the appellant so far.

The Commission directs the Public Information Officer to furnish available information duly adhering to the provisions of RTI Act 2005 to the appellant within (15) days from the date of receipt of this order and submit compliance to the Commission.

With the above direction, **the Appeal is closed.**

Issue **show cause notice** to Public Information Officer for not furnishing the sought information to the appellant within the stipulated time and for not attending hearing before the Commission. The action on the show cause notice shall be dealt with separately.
